Good Afternoon Chief Steinberg,

The Gila River Indian Community Grants Review Committee has completed its review of applications submitted for our 2017 grants cycle. I am pleased to inform you that the application submitted for the Sunsites-Pearce Fire District Rescue Stabilization Tools will be recommended for approval in the amount of \$11,000.00.

In order to move the application forward we will require a resolution from the Cochise County Board of Supervisors acknowledging their willingness to accept the grant from the Gila River Indian Community for the proposed amount and purpose. The Gila River Indian Community does not enter into formal Intergovernmental Agreements for the purpose of these grants, so this requested resolution along with the resolution approved by the Gila River Community Council will serve to effectuate this grant. Please be aware that this "Phase II" of the grant cycle does not constitute an actual award. Final approval is contingent upon the receipt of the requested Municipal Resolution no later than September 21, 2017 and by approval of the Gila River Indian Community Council. You will be notified of a final decision no later than October 25, 2017.

Congratulations on advancing to the next phase of the grant cycle! We are happy to support such a great effort that benefits so many of our Arizona residents.
