2. Adopt Resolution FCD 17-01, re-authorizing the acquisition of lands for a Flood Control project in the Willow Lakes area as described therein.

Ms. Karen Riggs, Highway & Floodplain Director, presented this item using a PowerPoint presentation. Ms. Riggs gave the background, showed a map of the area, gave the history of the subdivision, and noted that this had previously been denied by the Board due to a disagreement on the value of the land involved with gaining a drainage easement. She added that today's request would re-authorize staff to begin conversations with property owners again.

Chairman English said that she had voted against this project in the past because she thought that the property owner wanted more than the property was worth. She supported staff's proposal to renegotiate to move this project forward.

Vice-Chairman Call moved to adopt Resolution FCD 17-01, re-authorizing the acquisition of lands for a Flood Control project in the Willow Lakes area as described therein. Director Judd seconded the motion.

Chairman English called for the vote and it was approved 3-0.
