CALL TO THE PUBLIC

Chairman Judd opened the call to the public.

Ms. Alice Novoa, McNeal resident, addressed the Board on her concerns over Judge Alma Vildosola's citizenship and position as the Douglas City Magistrate and Justice of the Peace for Precinct 2.

No one else chose to speak and Chairman Judd closed the call to the public.

PRESENTATION

Presentation by Mr. Pascal Berlioux, Executive Director about the mission of the Eastern Arizona Counties Organization (ECO) and an update on the Mexican Wolf litigation.

Mr. Berlioux used a PowerPoint presentation to give the history of the Eastern Arizona Counties Organization and update the Board on current programs and projects. He specifically discussed the letter regarding the issue of the Mexican Wolf on the consent agenda and explained the principles on why this was critical.

Chairman Judd asked what the role of ECO was on water issues in the State.

Mr. Berlioux said that his organization was actively involved at the State level and would continue to be

involved in the upcoming year on water issues because all discussions were critical.

Vice-Chairman Call asked about matching grants.

Mr. Berlioux said that anyone could provide a match, but it had to be in cash, not in-kind funds.
