CALL TO THE PUBLIC

PRESENTATION

Presentation by Jesus Duarte, Health Educator, Douglas Youth Coalition regarding the emerging policy strategy to reduce youth tobacco use and increasing the tobacco sale age to 21.

Mr. Duarte and members of the Douglas Youth Coalition used a PowerPoint presentation to present their mission, vision, service to the community, examples of meetings with community leaders, community assessments, letters to the editor, presentations to the mayor and council, drafting of the ordinance and summary of the readings, key points of the ordinance and final passing of the ordinance on July of 2017.

The Board thanked the group for their participation and making a difference.

CONSENT

Board of Supervisors

1. Approve the Minutes of the regular meeting of the Board of Supervisors of September 25, 2018.

Finance

2. Approve demands and budget amendments for operating transfers. Warrants Nos. 28699-29185 were issued in the amount of \$2,121,652.41.

Pursuant to A.R.S. §11-217(C), the published minutes shall include all demands and warrants approved by the Board in excess of one thousand dollars except that multiple demands and warrants from a single supplier or individual under one thousand dollars whose cumulative total exceeds one thousand dollars in a single reporting period shall also be published. Workforce Development

3. Approve the reappointment of Mr. Matt Bolinger and appointment of Mrs. Jennifer Martin to the Local Workforce Development Board to fill an unexpired term, effective immediately through 6/30/2022.

Vice-Chairman Call moved to approve items 1-3 on the consent agenda. Supervisor English seconded the motion and it carried unanimously.

ACTION

4. Approve Memorandum of Understanding 2018-096 between the Department of Public Safety and Cochise County in the amount of \$166,666.67 to be used for prosecutorial and jail expenses incurred from individuals charged with drug trafficking, human smuggling, illegal immigration and other border related crime, effective July 1, 2018 through June 30, 2019.

Lt. Christy Heisner, Sheriff's Office presented this item. Lt. Heisner said this is the third year this MOU has come before the Board. Shared with the County Attorney's Office, a majority of the funding will be used for enhanced jail security to pay for key boxes. Mr. Bradshaw gave statistics for funding use; association with Stonegarden and importance of jail security and working with other border communities.

Vice-Chairman Call made a motion to approve Memorandum of Understanding 2018-096 between the Department of Public Safety and Cochise County in the amount of \$166,666.67 to be used for prosecutorial and jail expenses incurred from individuals charged with drug trafficking, human smuggling, illegal immigration and other border related crime, effective July 1, 2018 through June 30, 2019. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

Fleet Services

5. Approve contract award for the purchase of a Moffett MX8 Forklift from Hiab USA Incorporated, located in Phoenix, Arizona in the amount of \$56,304.

This item was presented by Ruben Miranda, Internal Services Administrator. Mr. Miranda said the contract was requested by the Public Works Director for the Solid Waste Department to handle construction materials that normally go through the compactor, that will result in a savings of approximately \$9,000 in repair costs to the compactor.

Supervisor English thanked Mr. Miranda for finding a solution to the problem.

Supervisor English made a motion to approve contract award for the purchase of a Moffett MX8 Forklift from Hiab USA Incorporated, located in Phoenix, Arizona in the amount of \$56,304. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.
