1. Approve the Minutes of the Flood Control District meeting for September 26, 2017.

2. Approve the Annual Joint Funding Agreement No. 18CMAZ00900 with United States Geological Survey (USGS) in the amount of \$70,400 for the period of October 1, 2017 to September 30, 2018 to conduct hydrologic investigations and data collection.

Mr. Joaquin Solis, Floodplain Engineer, presented this item. Mr. Solis said that this was an ongoing agreement for hydrologic investigations and data collection. He said the services of USGS were used nationwide to give engineers a good understanding of water flow in their communities.

Chairman English asked about the history with this data collection.

Vice-Chairman Call recommended that this item be tabled so that a representative from USGS could attend the meeting and give a presentation of how this agreement works and what data is being collected and how it is being used locally.

Director Judd moved to table this item until the February 13, 2018 Flood Control District meeting. Vice-Chairman Call seconded the motion.

Chairman English called for the vote and it was approved 3-0.
