CALL TO THE PUBLIC

Chairman Judd opened the call to the public.

No one chose to speak and Chairman Judd closed the call to the public.

CONSENT

Board of Supervisors

1. Approve the Minutes of the regular meeting of the Board of Supervisors of January 8, 2019.
2. Approve a letter authorizing the University South Foundation to use the Cochise County Regional Service Center located at 1012 N. G Avenue in Douglas for a fundraising event on March 23, 2019.

Community Development

3. Approve the reappointment of Mr. Sean Wales to the District 3 Board of Adjustment, for a term effective immediately to December 31, 2022.

Court Administration

4. Approve the acceptance of the Administrative Office of the Courts (AOC) Funding Agreement in the amount of \$25,738 for court security improvements effective May 1, 2018 through June 30, 2019.

Finance

5. Approve demands and budget amendments for operating transfers. Warrants Nos. 31093-31417 and 31419-31806 were issued in the amount of \$2,881,129.35.

Juvenile Probation

6. Approve Fiscal Year 2018-2019 Juvenile Probation Title IV-E funding agreement provided by the Arizona Supreme Court, Administrative Office of the Courts (AOC) effective July 1, 2018 through June 30, 2019 in the amount of \$44,448.89.

Workforce Development

7. Approve the appointment of Mr. Javier Villalobos to the Local Workforce Development Board to fill an unexpired term, effective immediately through June 30, 2022.

Vice-Chairman Call moved to approve items 1-7 on the consent agenda. Supervisor English seconded the motion and it carried unanimously.

ACTION

Board of Supervisors

8. Approve the over-the-counter sale of tax deed properties as set forth in the attached Exhibit A, plus related administrative fees.

Ms. Rios presented this item. She said that there had been five bids received for 32 parcels for a total sale of \$9,720 (\$8,920 for the bid and \$800 for the administrative fees).

Supervisor English moved to approve the over-the-counter sale of tax deed properties as set forth in the attached Exhibit A, plus related administrative fees. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

County Schools

9. Approve an Intergovernmental Agreement IGA-SABG-GR-19-100118-02 between the Cochise County School Superintendent's Office and the Governor's Office in the amount of \$212,000 effective October 1, 2018 through June 30, 2019 to educate students and their parents on substance and drug abuse.

Ms. Jaqui Clay, School Superintendent presented this item. She said this would be the second annual award for this program, which would bring youth and parents in one forum to learn about substance and drug abuse.

Vice-Chairman Call moved to approve an Intergovernmental Agreement IGA-SABG-GR-19-100118-02 between the Cochise County School Superintendent's Office and the Governor's Office in the amount of \$212,000 effective October 1, 2018 through June 30, 2019 to educate students and their parents on substance and drug abuse. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

County Sheriff

10. Approve an Intergovernmental Agreement (IGA) among Cochise College, Sierra Vista Police Department, and the Cochise County Sheriff's Office to assist Cochise College in operating a police academy in Cochise County.

Lieutenant Curtis Wilkins, Sheriff's Office, presented this item. Lt. Wilkins said that increased cost for the current training program was the major reason for establishing this program locally.

Supervisor English asked if the issues with the driving portion of the agreement had been resolved.

Lt. Wilkins said that they were working on finding a different location and reaching out to Pima County.

Supervisor English said that the changes should be made on the agreement to reflect updated information.

Mr. Gilligan said he would work with the partners involved to amend the contract and modify the language. He briefly went over the details in the memo he had prepared for the Board.

Mr. Hanson said he would revise language according to the memo, get it approved by all parties, then have Chairman Judd sign the amended agreement.

Supervisor English moved to approve an Intergovernmental Agreement (IGA) among Cochise College, Sierra Vista Police Department, and the Cochise County Sheriff's Office to assist Cochise College in operating a police academy in Cochise County and authorize the County Attorney to make changes as directed by the Board according to the memo put together by the County Administrator. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

Information Technology

11. Approve an Intergovernmental Agreement (IGA) between Cochise County and Fry Fire District for Information Technology Equipment and Support, effective January 29, 2019, with seven automatic annual renewals until January 29, 2026.

Mr. Joe Casey, Chief Information Officer, presented this item. Mr. Casey gave the background, explained the services that would be provided, and said his department had the capacity to provide this additional service.

Vice-Chairman Call moved to approve an Intergovernmental Agreement (IGA) between Cochise County and Fry Fire District for Information Technology Equipment and Support, effective January 29, 2019, with seven automatic annual renewals until January 29, 2026. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

12. Discussion and possible action regarding state and federal legislative matters listed or described in the attached County Supervisors Association Legislative Policy Committee (LPC) Agenda, the proposed State budget, and other matters related thereto.

Supervisor English gave an overview of the discussion and asked if the Board wanted to take any formal action regarding any of the topics on the LPC agenda.

The Board agreed not to take any formal action and thanked Supervisor English for serving as the representative.

Mr. Gilligan discussed the Cochise Combined Trust annual meeting and noted that the health trust was financially stable and in the future he would be presenting slight modifications to the health plans for Board approval.

Vice-Chairman Call said he had attended the Cochise County Recharge Network (CCRN) meeting and they had been able to secure a grant for the local Natural Resources Conservation Service (NRCS) for The Water Project, which is a non profit organization. He added that the Federal Reserve Water Rights trial had begun and he would be testifying the week of the next board meeting

and would have to be absent from that board meeting.

Report by District 3 Supervisor, Peggy Judd

Chairman Judd said that she would be attending the Western Regional Water Conference in Phoenix and encouraged citizens to visit Whitewater Draw to see the Sandhill Cranes.
