CALL TO THE PUBLIC

Chairman Judd opened the call to the public.

No one chose to speak and Chairman Judd closed the call to the public.

This is the time for the public to comment. Members of the Board may not discuss items that are not specifically identified on the agenda.

CONSENT

Board of Supervisors

1. Approve the Minutes of the regular meeting of the Board of Supervisors of February 26, 2019.
2. Approve the over-the-counter sale of tax deed properties from the Special Meeting auction held on March 5, 2019 as set forth in attached Exhibit A, plus related administrative fees.

Elections

3. Approve the appointment of 14 Democrat Precinct Committeemen and 8 Republican Precinct Committeemen by recommendation of their Cochise County Party Chairmen to serve through the October 1, 2020 term.

Finance

4. Approve demands and budget amendments for operating transfers. Warrants Nos. 32321-32576 were issued in the amount of \$1,024,048.75.

Pursuant to A.R.S. §11-217(C), the published minutes shall include all demands and warrants approved by the Board in excess of one thousand dollars except that multiple demands and warrants from a single supplier or individual under one thousand dollars whose cumulative total exceeds one thousand dollars in a single reporting period shall also be published. Issued warrants are listed as an attachment at the end of the minutes.

Supervisor English moved to approve items 1-4 on the consent agenda. Supervisor Borer seconded the motion and it carried unanimously.

ACTION

Board of Supervisors

5. Elect _____ as Chairman of the Board of Supervisors, effective _____, 2019.

Supervisor English said that this was not needed at this time, but a vice-chairman vote would be needed due to Mr. Call's departure.

Chairman Judd removed this item from the agenda.

6. Elect _____ as Vice-Chairman to the Board of Supervisors, effective _____, 2019.

Supervisor English said that this item was needed since Mr. Pat Call had been appointed to the Justice of the Peace, Precinct 5. She added that with a new member on the Board, she would volunteer to fill this role.

Chairman Judd said having Supervisor English as the Vice-Chairman would allow for Mr. Borer to become more familiar with his duties as a Supervisor and thanked Supervisor English for volunteering.

Supervisor English moved to elect Ann English as Vice-Chairman to the Board of Supervisors, effective March 12, 2019. Supervisor Borer seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

7. Renew and/or revise amendment 1 to the committee appointments for members of the Board of Supervisors and executive staff for the remainder of Fiscal Year 2018-19 and approve continuing annual memberships for 2018-19, with payment of associated dues as described herein.

Ms. Rios presented this item and noted that there had been several changes made to replace Mr. Pat Call with current members of the Board. She noted that she had sent the list to the Board for their review and would make any changes if necessary.

The Board said that they were in agreement with the proposed appointments.

Supervisor Borer moved to approve amendment 1 to the committee appointments for

members of the Board of Supervisors and executive staff for the remainder of Fiscal Year 2018-19 and approve continuing annual memberships for 2018-19, with payment of associated dues as described herein. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

Court Administration

8. Approve revised pricing structure for Contract Amendment 5, 16-10-SUP-03 for Remote Court Reporting in the amount of \$147,000 per fiscal year.

Mr. Eric Silverberg, Court Administrator and Mr. Brandon Morrison, Contracts Administrator presented this item. Mr. Morrison gave the background and said that this amendment extended this service to all interested parties and revised the cost structure.

Mr. Silverberg gave a brief background on the service.

Supervisor English moved to approve revised pricing structure for Contract Amendment 5, 16-10-SUP-03 for Remote Court Reporting in the amount of \$147,000 per fiscal year. Supervisor Borer seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

Information Technology

9. Approve 5-year blanket contract with Pre-venTronics for County Access Control System in the amount of \$89,817.14 for the installation of access controls for the Melody Lane Complex and future projects, effective March 12, 2019.

Mr. Brandon Morrison, Contracts Administrator, presented this item. Mr. Morrison explained the service and how it would impact future projects.

Supervisor Borer moved to approve 5-year blanket contract with Pre-venTronics for County Access Control System in the amount of \$89,817.14 for the installation of access controls for the Melody Lane Complex and future projects, effective March 12, 2019. Supervisor English seconded the motion.

Mr. Gilligan said that this project was a priority and would address security and key control issues.

Chairman Judd called for the vote and it was approved 3-0.
