2. Approve contract 19-33-HFP-01 between Cochise County and J.E. Fuller/Hydrology and Geomorphology, Inc. for monitoring services in the amount of \$120,567, effective March 12, 2019 through March 31, 2020.

Ms. Jackie Watkins, Engineering and Natural Resources Director, said Ms. Riggs would discuss the background of the item.

Ms. Karen Riggs, Consultant, presented this item. Ms. Riggs gave the history of this service and said that service would focus on the monitoring of the stream flow to help project future project costs. She noted that The Nature Conservancy was a partner in helping fund these projects.
