**Board of Supervisors**

1. Approve the Minutes of the Flood Control District meeting for August 27, 2019.

Supervisor Judd moved to approve item 1 on the consent agenda. Vice-Chairman English seconded the motion and it carried unanimously.

2. Approve agreement conveying San Ignacio Del Babocomari Parcel Number 106-15-030L from The Nature Conservancy to the Cochise County Flood District, granting a Conservation Easement to The Nature Conservancy and authorize the Board Chair to execute all documents necessary to close the transaction.

Ms. Christine Roberts, Civil Deputy County Attorney, presented this item. She stated that the property was a 104 acre parcel in the San Ignacio area of Babocomari and the purpose was for it to be part of the County's recharge project. She added that the Board was briefed on the property and staff was asking for approval of an agreement conveying the property to

the County. She noted that the County would not be able to sell any of the land, but would be able to allow grazing.

Supervisor Judd moved to approve agreement conveying San Ignacio Del Babocomari Parcel Number 106-15-030L from The Nature Conservancy to the Cochise County Flood District, granting a Conservation Easement to The Nature Conservancy and authorize the Board Chair to execute all documents necessary to close the transaction. Vice-Chairman English seconded the motion.

Vice-Chairman English called for the vote and it was approved 2-0-1 (Borer absent).
