

ZONING ORDINANCE 20-___

**REVERTING CERTAIN ZONING DISTRICT BOUNDARIES
FROM TR-36 TO RU-4, PURSUANT TO THE APPLICATION
OF LISA AND MICHAEL CARROLL**

WHEREAS, Arizona Revised Statutes (“A.R.S.”) § 11-814 allows property owners or their authorized agent to request amendments to the Zoning District boundaries through the Board of Supervisors in a public hearing; and

WHEREAS, the Cochise County Board of Supervisors (“Board of Supervisors”) recognizes that zoning amendments can affect land use patterns and therefore, warrant careful consideration of local and regional impacts at a public hearing; and

WHEREAS, Tax Parcels 106-15-045B, 045C, 045D, 045E, 045F were granted a conditional rezoning in 2006 from RU-4 to TR-36 to facilitate a residential subdivision; and

WHEREAS, the conditions of the rezoning were never completed (including the submission of a subdivision plat); and

WHEREAS, the Applicants, Lisa and Michael Carroll, subsequently acquired the parcels of land and the Applicants do not wish to pursue the proposed subdivision and want to revert the zoning to RU-4; and

WHEREAS, pursuant to A.R.S. § 11-814, the Board of Supervisors can revert zoning, if the property has not been improved for the use for which it was conditionally approved; and

WHEREAS, the requested zoning district represents a reduction in density; and

WHEREAS, the requested zoning district is harmonious with the surrounding zoning districts; and

WHEREAS, the Board of Supervisors promotes effective, early and continuous public participation by citizens; and

WHEREAS, the Board of Supervisors held a duly noticed public hearing on the reversion of the zoning of Tax Parcels 106-15-045B, 045C, 045D, 045E, 045F as requested by the applicants, Lisa and Michael Carroll.

NOW, THEREFORE, BE IT RESOLVED that the zoning of Tax Parcels 106-15-045B, 045C, 045D, 045E, 045F is reverted from TR-36 to RU-4. The property is located in the Babocomari Land Grant in Huachuca City, AZ. The property is further described as being in Township 20 South, Range 20 East of the G&SRB&M in Cochise County, Arizona. The Board of Supervisors approves Docket Z-20-07 subject to the following condition:

1. The Applicants shall provide the County with a signed Acceptance of Conditions, and a Waiver of Claims form arising from A.R.S. § 12-1134, signed by the property owner of the subject property within thirty (30) days of Board of Supervisors approval of the rezoning.
