Thank you for your patience as we worked through the 2020 Gila River Indian Community grant cycle. We are very much behind our normal schedule however the Grants Review Board has now completed their review of all grant proposals. The application for Sunsites-Pearce Fire District, Handheld Radios project is being recommended for approval in the amount of \$44,682.00.

I will begin preparing the necessary documents for final approval by the Gila River Indian Community, Community Council however per policy, we do require a resolution from the City in order to acknowledge acceptance of the grant for use in the purpose identified in the grant application. Please let me know your timeline in obtaining a City Resolution. If we cannot get it rather quickly we can discuss a written acknowledgement to include in the packet until the Resolution is approved.
