1. Approve the Minutes of the Flood Control District meeting for July 14, 2020.

2. Approve the Annual Joint Funding Agreement No. 20ZFJFA2600 in the amount of \$16,210 for the operation and maintenance of the stream gages for the period October 1, 2019 to September 30, 2020.

Ms. Jackie Watkins, Engineering & Natural Resources Director, presented this item stating they have two contracts with the United States Geological Survey (USGS) to provide bond training and gage monitoring on the San Pedro River for the Charleston gage by San Pedro and the Babocomari River near Tombstone. She stated this is an annual fee for the two fees they receive from (USGS).

Vice-Chairman English questioned the timeframe of the agreement stating there are only a couple of months left for it to expire. Ms. Watkins said they have two contracts with them, which renew at different times, but they will be combined into one so this does not occur again.

Chairman Borer asked if we had received any public comment on this item and Ms. Tucker stated there was none.

Vice-Chairman English made a motion to approve the Annual Joint Funding Agreement No. 20ZFJFA2600 in the amount of \$16,210 for the operation and maintenance of the stream gages for the period October 1, 2019 to September 30, 2020. Supervisor Judd seconded the motion.
