Thank you for reaching out. You are correct, the notice is not showing on the public side of the website. I will be working with our IT Department to correct that. In the meantime, I have attached the notice that I mailed to you and their application.

Background and where we are.....

The Greens submitted an ALQ application and we received your letter in opposition. Pursuant to Section 1717.02 of the Zoning Regulations we are required to deny that application. The Applicant is then allowed by Code to submit a Special Use Application and make their case to the Planning and Zoning Commission. That is where we are today.
