Secretary Hobbs:

Pursuant to A.R.S. §16-602, Cochise County conducted a hand count audit of the August 4, 2020 Primary Election.

The Cochise County Party Chairs from the Democratic and Republican Parties met at 2:00 pm on August 5, 2020 to begin the hand count audit process. They randomly chose, by lot, the following Vote Centers and batches:

Vote Center 4 Willcox – 288 ballots cast Vote Center 6 Huachuca City – 244 ballots cast
Batch #80 with 200 early ballots cast Batch #110 with 200 early ballots cast.

Four contested races were audited as required by law for the Primary Election. Specifically, the following races were randomly drawn by lot and counted:

Federal Candidate – US Representative in Congress District 2 (REP)
Statewide Candidate – Corporation Commission (REP)
Statewide Legislative – State Senate District 14 (DEM)
Statewide Candidate – Corporation Commission (DEM)

Ten hand count members, five each from the Democratic and Republican Parties convened at 10:00 am on August 8, 2020 to begin the hand count. Following the administration of the Oath to all present and providing instructions, the physical hand count began. The tabulation method used was the stacking method. The hand count was conducted by 3 boards, consisting of 3 members with one Auditor.

The Board adjourned at 1:30pm with the hand count audit had been completed successfully.

Attached is the summary report, which depicts the results of the hand count audit for each race. I am happy to report that everything that was hand counted matched the machine determined results with only a .17% discrepancy in one race counted by Board #2. That falls well into the acceptable range with the Party's being satisfied we met our legal obligation. They chose not to recount the race.
