### Housing Opportunities for Persons With AIDS Amendment

This Amendment is to the Grant Agreement dated 2/23/2021 (Grant Agreement), Grant Number AZ-H200016 (Grant), between the United States Department of Housing and Urban Development (HUD) and Housing Authority of Cochise County (Grantee).

Whereas HUD awarded a Grant to the Grantee and sent a signed Grant Agreement to the Grantee for their signature; and


