

**RESOLUTION 21-**

**AUTHORIZING THE ADDITION OF A PORTION OF  
ELMER LOOP LOCATED IN HEREFORD TO THE  
COCHISE COUNTY MAINTAINED ROAD SYSTEM**

**WHEREAS**, the Board of Supervisors (“Board”) is authorized to lay out, maintain, control, and manage public roads under its jurisdiction, pursuant to A.R.S. § 11-251(4); and

**WHEREAS**, on November 13, 1989, the Board approved the official Cochise County Maintained Road System Maps, by Resolution 89-107, which has been amended from time to time; and

**WHEREAS**, the Board may spend public monies for maintenance of public roads and streets other than legally designated state and county highways pursuant to A.R.S. § 28-6705(A1); and

**WHEREAS**, there has been presented to the Board a formal request to add .22 miles of Elmer Loop in the Hereford area to the County’s Road Maintenance System, as depicted in the map in Exhibit A, attached hereto; and

**WHEREAS**, the Board, having considered comments regarding this request at their regular meeting held on April 20, 2021, has determined that approving the addition of 0.22 miles of Elmer Loop in the Hereford, as specified above would be in the best interest of Cochise County and the public at large.

**NOW, THEREFORE IT IS HEREBY RESOLVED**, that we, the Board of Supervisors of Cochise County, do hereby approve the following revision to be made to the Cochise County Maintained Road System Maps:

**MAP PAGE 9N**

Elmer Loop #1370 – Add Elmer Loop, from the Intersection of Elmer Loop and Jenny Drive 0.22 miles to Edward V Drive.

**IT IS FINALLY RESOLVED** that we, the Board of Supervisors, do hereby approve the addition of 0.22 miles of maintenance on the road described above.

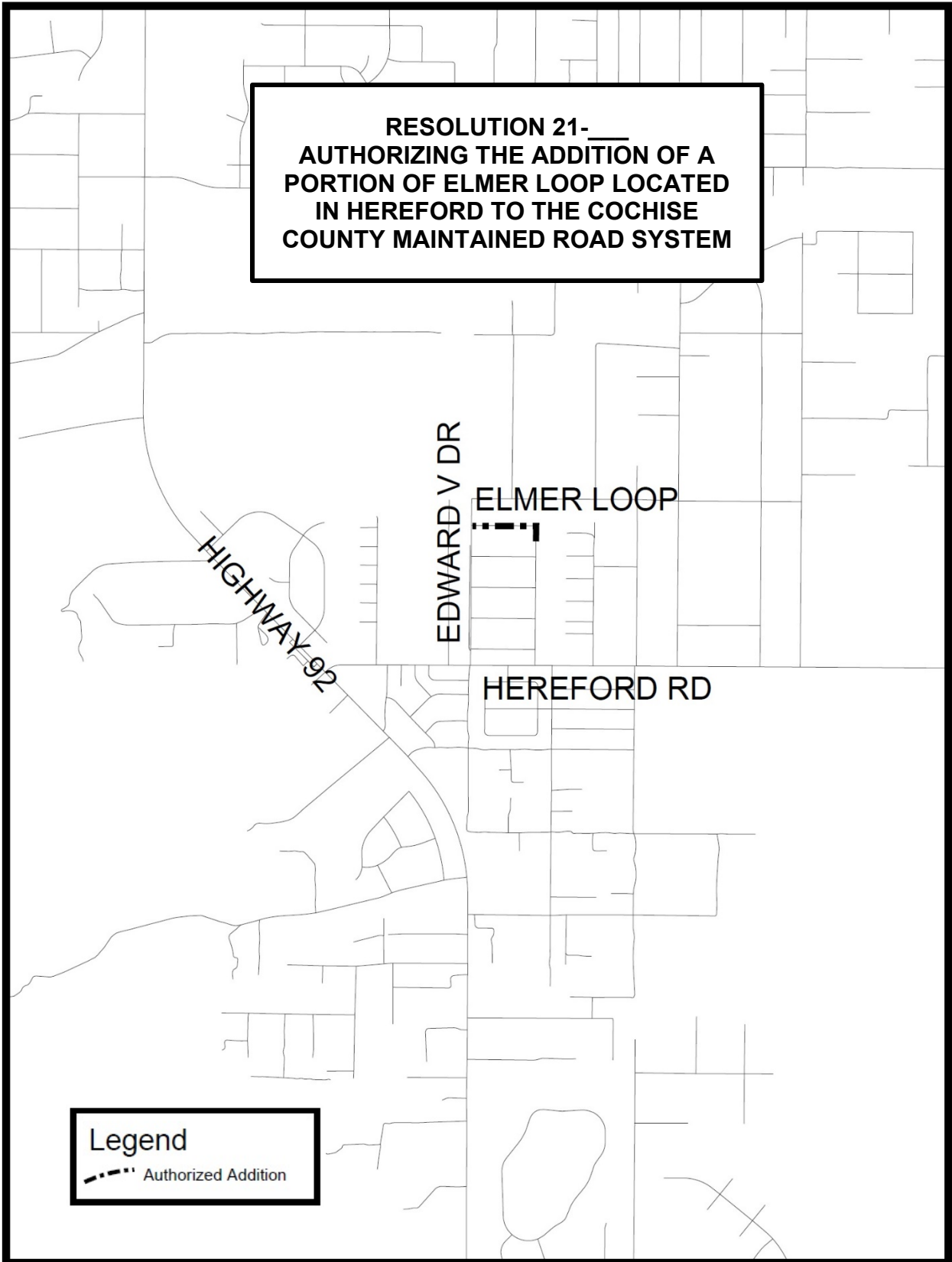
