

RESOLUTION 21-\_\_\_

AUTHORIZING COCHISE HEALTH AND SOCIAL SERVICES TO REVISE  
THE SCHEDULE OF FEES FOR THE REPRODUCTIVE HEALTH PROGRAM

WHEREAS, A.R.S. § 36-182 establishes county departments of health for the purpose of providing local health services; and

WHEREAS, Cochise Health and Social Services desires to provide services to all individuals requesting reproductive health services regardless of income or poverty level; and

WHEREAS, this matter was noticed for public hearing, as required by A.R.S. § 11-251.08, and following this hearing the Board of Supervisors for the County of Cochise determined that these proposed revisions to the fees of the Reproductive Health Program are necessary and appropriate.

IT IS HEREBY RESOLVED that the Board of Supervisors for the County of Cochise adopts the following schedule of fees (as set forth in Exhibit A, attached hereto) for reproductive health services provided by the County.

BE IT FURTHER RESOLVED that any and all prior fee schedules adopted for the Reproductive Health Program are hereby rescinded, effective with the passage of this Resolution.

Pursuant to A.R.S. 11-251.08, the general public is hereby notified that the Cochise County Board of Supervisors will hold a public hearing on December 14, 2021 at 10:00 A.M. to consider the implementation of a sliding fee scale and the following fee changes to the Reproductive Health Program.

Service	Proposed Fee (Full Price)
Comprehensive Preventive Visit (not including a pelvic exam)	\$25
Comprehensive Preventive Visit (including pelvic exam)	\$50
Depo-Provera Injection (3 month birth control shot)	\$35/injection (\$140/year)
Oral Birth Control Pills	\$10/cycle (\$120/year)
Cyclebeads (Natural Family Planning/Fertility Awareness)	Free
IUD Insertion	\$80
IUD Removal	\$40
IUD	Cost of device (dependent on which IUD client chooses)
Pregnancy Tests (if only service being performed)	\$5
Emergency Contraception	\$15
Condoms	Free

\*\*Comprehensive visit includes: Height, Weight, Blood pressure, Thyroid, Heart, Lungs, Extremities, Breast, Abdomen, Pregnancy test, Chlamydia and Gonorrhea test
