**A RESOLUTION OF THE BOARD OF SUPERVISORS OF COCHISE COUNTY CANCELING THE
REGULAR ELECTIONS OF AUGUST 2, 2022 FOR CERTAIN PRECINCT COMMITTEE
PERSONS OF CERTAIN PRECINCTS IN WHICH NO ELECTION IS REQUIRED**

NOW THEREFORE BE IT RESOLVED By the County of Cochise as follows:

1. The elections of the Precinct Committee persons, scheduled for August 2, 2022, are canceled pursuant to the authority granted to the Cochise County Board of Supervisors.
2. The persons listed above are hereby deemed appointed Precinct Committee persons in the designated precincts in Cochise County.
3. A person who is appointed pursuant to this section shall be deemed an elected Precinct Committee person and will be fully vested with the powers and duties of the office for a two-year term beginning October 1, 2022.
4. If no nomination petitions for a candidate and no nomination papers for a write-in candidate have been filed to fill the position for which the election was being

held, the position is deemed vacant and shall be filled in accordance with laws governing the filling of those vacancies.

5. This action is taken pursuant to the authority granted the Cochise County Board of Supervisors under A.R.S. § 16-410(A).
