2. Approve the Annual Joint Funding Agreement No. 23ZFJFA00080100_00 between the United States Geological Survey (USGS) and Cochise County in the amount of \$59,810 for the period of October 1, 2022, to September 30, 2023, to conduct hydrologic investigations and data collection.

Vice-Chairman Judd made a motion to approve the Annual Joint Funding Agreement No. 23ZFJFA00080100_00 between the United States Geological Survey (USGS) and Cochise County in the amount of \$59,810 for the period of October 1, 2022, to September 30, 2023, to conduct hydrologic investigations and data collection. Chairman English seconded the motion.

Mr. Apel presented this item using a PowerPoint presentation. This request is approve a new Annual Funding Agreement (Agreement), for hydrologic monitoring in the Sierra Vista Subwatershed of the Upper San Pedro Basin. He reviewed the monitoring efforts of various agencies. A 2019 report from the USGS found that water levels declined throughout the Sierra Vista Subwatershed. A well sweep in 2019 by the Arizona Department of Water Resources found an average decline of 3.9 feet since 2007 in 77.5% of the wells monitored in that period. This year's Agreement is discounted by \$18,000 due to one-time contributions by the Bureau of Land Management (BLM).

The Board and Mr. Apel discussed the information available on the website uppersanpedropartnership.org; the decline of water levels from 2007-2019; and, the depth of the aquifer. Supervisor Crosby discussed his concerns regarding implementation of the San Pedro Riparian National Conservation Area (SPRNCA) and the BLM's jurisdiction.

Chairman English called for the vote and it was approved 2-1 (Crosby opposed).

Chairman English adjourned the meeting at 10:14 a.m.
