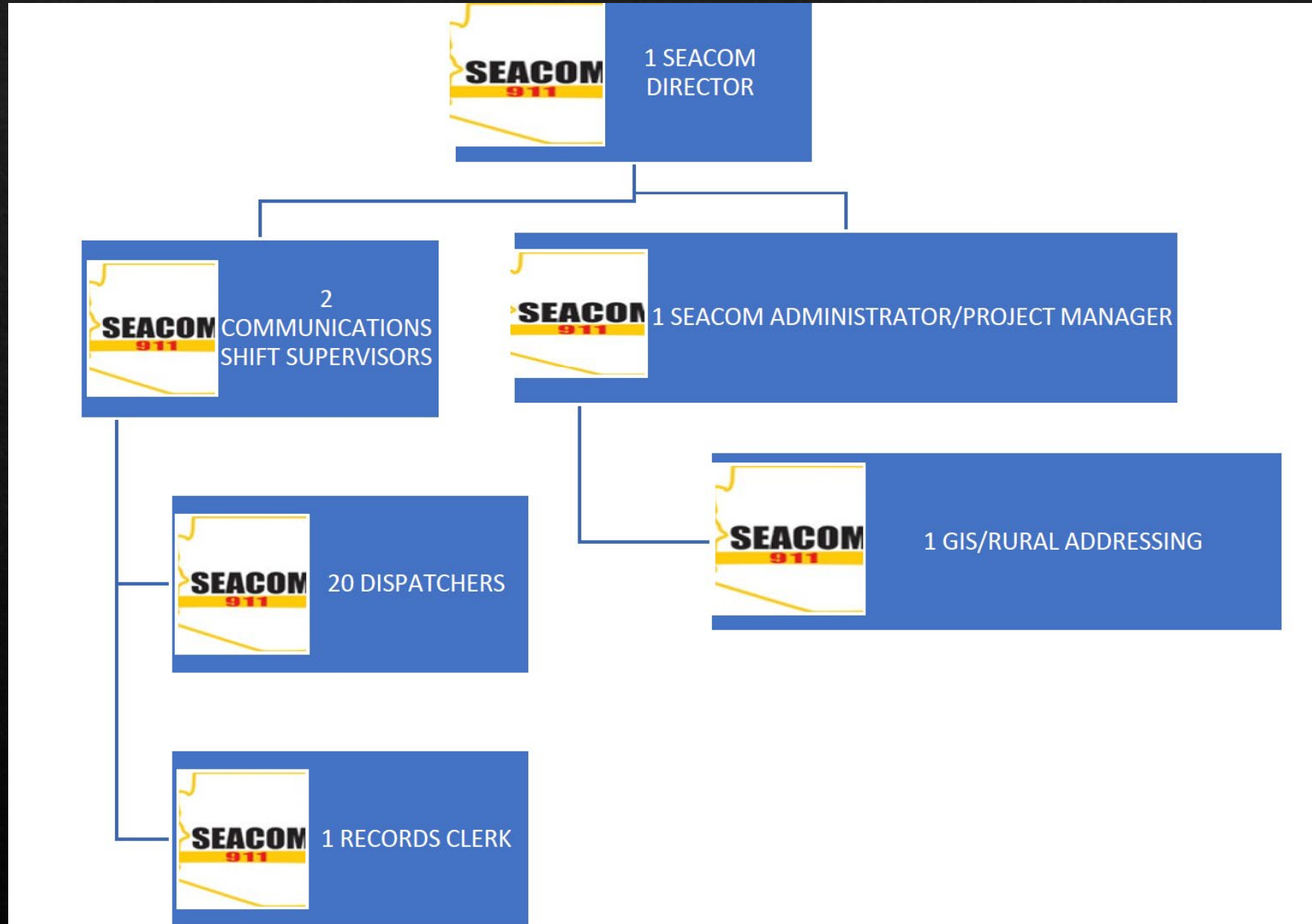

Personnel Compensation Adjustments

- ✓ March 2022.... 4% market shift and a 2% step increase.
- ✓ July 2022..... 4% market shift and a 2% step increase.
- ✓ Jan. 2023..... 2% market shift.

These adjustments are made as part of the City of Sierra Vista (CSV) ongoing effort to be competitive in the workplace and be consistent with the Classification Compensation system.
