I am writing to express my family's opposition to the granting of a special use authorization which would allow the placing of a cell tower on the land at 3182 Acacia Lane.

Our parcel is within 1000 ft. of the proposed structure, and we feel it would create a new eyesore which would adversely affect the value of our land. The siting of a tall structure like this in a mostly residential area, which has especially good views is inconsistent with the current land use, and would be a detriment to the surrounding area. It's our belief that these kinds of commercial uses should be clustered, rather than scattered through an area whose best asset is open vistas.
