

**RESOLUTION 24-\_\_\_**

**AMENDING THE COMPREHENSIVE PLAN DESIGNATION FROM DEVELOPING TO RURAL RESIDENTIAL AND COMPREHENSIVE GROWTH CATEGORY FROM B TO D ON THE COMPREHENSIVE PLAN GROWTH AREA AND LAND JURISDICTION MAP PURSUANT TO REQUEST OF DOCKET CPA 23-04**

**WHEREAS**, Arizona Revised Statutes (“A.R.S.”) §§ 11-804, et seq. requires the County Board of Supervisors (the “Board”) to formulate comprehensive plans for the purpose of guiding and accomplishing a coordinated, adjusted, and harmonious development of the County; and

**WHEREAS**, the current comprehensive plan was re-adopted in 2015, pursuant to A.R.S. §§ 11-805(M), which requires the Board to re-adopt the Plan every 10 years; and

**WHEREAS**, the Board recognizes that plan designations can affect land use patterns and therefore warrant careful consideration of local and regional impacts at a public hearing; and

**WHEREAS**, ARS §11-829 allows property owners or an authorized agent to request amendments to the Comprehensive Plan, Area Plans and Zoning District boundaries through the Board of Supervisors in a public hearing; and

**WHEREAS**, the request to change the plan designation of 25.8 acres is subject to this Resolution and as indicated in Exhibit A from Developing to Rural Residential and to change the plan growth area category from B to D is consistent and harmonious with the existing growth pattern and development in the area; and

**WHEREAS**, the 25.8 acres identified in Docket CPA 23-04 are in a planning area that will be re-evaluated during the 2025 Cochise County Comprehensive Plan update; and

**WHEREAS**, the proposed changes are to select parcels identified in Comprehensive Plan Growth Areas and Land Jurisdiction Map of the Comprehensive Plan only and will not affect the general text of this document; and

**WHEREAS**, on March 26, 2024, the Board of Supervisors held a duly noticed public hearing of this proposed map amendment and attached hereto as Exhibit A and found it to be in the public interest.

**NOW, THEREFORE, BE IT RESOLVED THAT** by the Board of Supervisors of Cochise County, Arizona that the Cochise County Comprehensive Plan Growth Areas and Land Jurisdiction Map shall be amended as contained in Exhibit A, attached hereto.
