**PURSUANT TO THE INTERGOVERNMENTAL AGREEMENT (IGA) SECTION 12.0 AMENDMENTS, THE PARTIES HEREBY AGREE TO AMEND THE AGREEMENT AS FOLLOWS:**

1. **Section 5.2 Other Requirements, Subsection 5.2.11 is revised to read as follows:**
  - 5.2.11 **Provide information regarding the dates and case numbers of adoptions and termination of parental rights and the Notice of Completed Adoption as required by the Rules of Procedure for the Juvenile Court, and as requested by ADES, County Attorneys or the Attorney General's Office so support orders may be stopped or modified.**
  
2. **Section 30.0 PERFORMANCE, Subsection 30.1.2 is revised to read as follows:**
  - 30.1.2 **Any tax return or tax return information made available in any format shall be used only for the purpose of carrying out the provisions of this contract. Information contained in such material will be treated as confidential and will not be divulged or made known in any manner to any person except as may be necessary in the performance of this contract. Disclosure to anyone other than an officer or employee of the Clerk, unless otherwise required by an Arizona Court Rule, will be prohibited.**

**EXCEPT AS PROVIDED HEREIN, ALL TERMS AND CONDITIONS OF THE ORIGINAL CONTRACT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECTS. THE AMENDMENT SHALL BECOME EFFECTIVE ON THE DATE OF LAST SIGNATURE UNLESS OTHERWISE SPECIFIED HEREIN. BY SIGNING THIS AMENDMENT ON BEHALF OF THE CONTRACTOR, THE SIGNATORY CERTIFIES HE/SHE HAS THE AUTHORITY TO BIND THE CONTRACTOR TO THIS CONTRACT.**
