We are requesting this grant be extended to **December 31, 2024**. This grant is for \$250,000.00 and is being used to purchase consoles for the E911 system. These consoles will be used to make the Douglas Police Department the hot backup E911 site for SEACOM. The original contract term is October 1, 2022, to December 31, 2023.
