



4. THE PARTIES AGREE TO THE FOLLOWING AMENDMENT <p>Pursuant to section 9, AMENDMENTS of the original agreement, this amends the Agreement dated December 13, 2022. The following section 7.1.19 is replaced in its entirety to update the date as follows:</p> <p>Provide DCS an anticipated projection of allowable costs by June 15th, to be claimed the following federal fiscal year. The actual transfer amount will depend on county expenditures that qualify for FFP under Title IV-E.</p>

THIS AGREEMENT MAY BE EXECUTED IN ANY NUMBER OF COUNTERPARTS, EACH OF WHICH WHEN EXECUTED AND DELIVERED SHALL CONSTITUTE A DUPLICATE ORIGINAL, BUT ALL COUNTERPARTS TOGETHER SHALL CONSTITUTE A SINGLE AGREEMENT.
