

Hello,

My name is Louis Hahn and I live at 5360 N. Rocky Rd. I am contacting you regarding the placement of the telecom facility that is being placed on the property located at 5590 N. Rocky Rd. I am opposed to the placement of the said antenna not only from the health perspective but also to the close proximity of my property which is within 750 feet (My Parcel # 40753028). The property that the antenna is being placed on is zoned R36-residential district, and this tower is not residential. I have concerns that the tower will adversely affect my health and property value.

I am 100% disabled veteran who has been exposed to plutonium/uranium and radiation. Due to this exposure I am fearful of being re-exposed to additional elements. I had cancer due to this exposure which resulted in the loss of my jaw as well as had to undergo extreme chemo therapy and radiation. Due to the loss of my jaw I am on a feeding tube and cannot eat or drink orally.

All of this information is documented thru the VA and private doctors and documentation can be provided if needed.

I am sending you this email via my daughters email address. I do not have computer access or a smart phone. Due to my age and my health as well as being on my feeding tube, I am limited on the amount of time I can spend away from home so I am unable to attend a public hearing. I also am unable to communicate clearly due to the removal of my jaw.

Please respond to this email address confirming that you received it and read my concerns. I would like an official response sent to this email as well as a written response mailed to my address above so I can take further action if needed.
