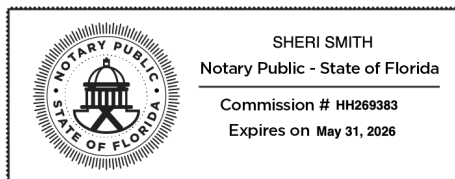

**Docket RZ24-23 (Purdy Lane)**
