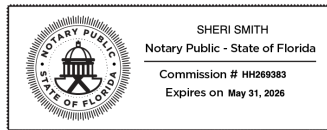

The County received concurrent rezoning and special use authorization applications from Pedro De Castro (applicant) to rezone APN 407-83-006 from R-36 (Residential District, one dwelling per 36,000 square feet) to RU-4 (Rural District, one dwelling per 4 acres) to allow an Impound Storage Yard on property located along the north side of W. Denham Road ¼ mile east of N. Highway 191. The undeveloped parcel totals about 40 acres and is located west of Douglas.
