The County received a rezoning application from Adapture Renewals (applicants) to rezone APNs 203-16-007, 203-19-018A, 203-19-036C, 202-44-012 (part), 202-44-017, 202-67-002 (part), and 202-86-002 from R-36 (Residential District, one dwelling per 36,000 square feet to RU-4 (Rural District, one dwelling per 4 acres). The parcels total about 880 acres and are located east of Willcox.
