Proposal for Funding Support from the Cochise County Sheriff's Office

In response to a recent offer by the Cochise County Sheriff's Office to provide funding in support of the SVPD K9 Program, we'd like to accept funding to outfit two Chevrolet Tahoes with specialized K9 cages. This project builds on our ongoing partnership with CCSO and will further strengthen regional public safety efforts.

The SVPD has recently acquired two new K9s. Our current K9 vehicles have high mileage and are due for replacement, making the outfitting of newer Tahoes a priority. Each cage costs approximately \$12,000, for a total project cost of \$24,000.

One of the K9 handlers is assigned to the regional SWAT team, ensuring these resources will enhance both local and county-wide operations.

We respectfully request \$24,000 to outfit two Tahoes with K9 cages. An estimated cost proposal from Waltz Outfitting is attached for your review.

We greatly appreciate your consideration of this request and look forward to your response.

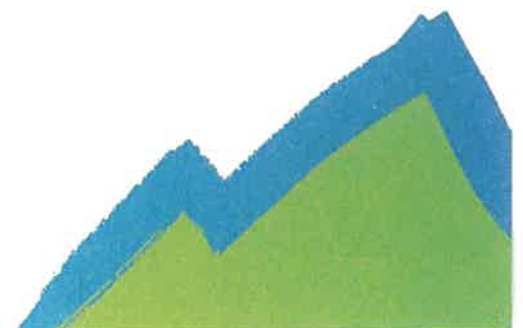
