The Arizona Department of Emergency & Military Affairs, Division of Emergency Management, is pleased to provide you with this **Final Grant Award letter** for the above reference grant. The amount of Federal funds awarded to **Cochise County** is **\$125,059.50**.

As a condition of the award, you are required to contribute a cost match in the amount of **\$125,059.50** of non-federal funds, or 50 percent of the total approved project costs of **\$250,119.00**. EMPG funds may be obligated and expended within the period of performance from **July 1, 2025 - June 30, 2026**, and in accordance with the EMPG grant guidelines.

All expenditures made with grant funding must adhere to all federal regulations and requirements as outlined in the Agreement, EMPG Notice of Funding Opportunity, and DEMA EMPG Local Programmatic Guidance. Also, each grant award will be monitored for both programmatic and fiscal compliance through desk monitoring and scheduled site monitoring visits.
