### **Community Development**

4. Approve an extension request of the Assurance Agreement for The Oaks Subdivision with Pioneer Title Agency, Inc., as Trustee under Trust No. 319061 for Castle & Cooke Arizona, Inc as Beneficiary of Trust No. 319061 to May 9, 2020.

Mr. Paul Esparza, Planning Manager, presented this item using a PowerPoint Presentation. Mr. Esparza provided the background and said this is the third request to extend the assurance agreement for The Oaks Subdivision. He showed a map of the location, described the subdivision and gave plat approval dates. He stated the factors used in consideration of this request: property taxes are current; 26% of improvements have been made exceeding the required 20%; the Monument Fires affected the economic conditions for the subdivision development; and staff addressed an issue raised that there was not an adequate water supply in place to supply this subdivision. The Operations Manager at Liberty Utilities was contacted and stated that the infrastructure is in place: a well was installed nearby and water storage facility to provide water service to each lot within the subdivision. Staff recommends approval of this assurance agreement extension.

The Board had no questions and Chairman English stated this subdivision is viable with improvements well documented.

Vice-Chairman Call moved to approve an extension request of the Assurance Agreement for The Oaks Subdivision with Pioneer Title Agency, Inc., as Trustee under Trust No. 319061 for Castle & Cooke Arizona, Inc as Beneficiary of Trust No. 319061 to May 9, 2020. Supervisor Judd seconded

the motion.
