CALL TO THE PUBLIC

Chairman English opened the call to the public.

No one chose to speak and Chairman English closed the call to the public.

This is the time for the public to comment. Members of the Board may not discuss items that are not specifically identified on the agenda.

PRESENTATION

Presentation by Moiria White of Coronado Farms.

Ms. White used a PowerPoint presentation to brief the Board on the Coronado Farms operations. Ms. White gave background on her position and the organization. She noted that she wanted to present information on the Coronado Farms to the Board so that they could share with the community the mission of this organization. She reviewed the entire operation as a whole and discussed the main operations in Arizona. She said that she encouraged the public and County employees to visit the farms and learn more about how they were impacting the local economy. She noted that the organization was aware of water conservation and would work towards this same goal.

The Board thanked Ms. White for her presentation.

Vice-Chairman Call moved to approve items 1-4 on the consent agenda. Supervisor Judd seconded the motion and it carried unanimously.

PUBLIC HEARINGS

Board of Supervisors

5. Adopt Resolution 17-13 granting a Telecommunications and Fiber Optic Services franchise to Level 3 Communications, LLC.

Mr. Hanson presented this item. He gave the background and said that it was a standard franchise, but he was requesting the item be tabled in order to give him an opportunity to discuss a legal language disagreement with the applicant's legal counsel.

Vice-Chairman Call asked what the disagreement was.

Mr. Hanson clarified that under Arizona State law the applicant can not ask that the County reimburse the applicant for costs of having to move equipment due to County right-of-way work. In this case the applicant does not agree that this should be detailed in the franchise agreement.

He also suggested opening the public hearing in case anyone in the audience had attended to comment.

Vice-Chairman Call asked Ms. Riggs for input on this process.

Ms. Riggs said that it was critical the legal language stayed in the franchise to ensure that the County's rights are respected.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Supervisor Judd moved to table this item to the August 22, 2017 meeting. Vice-Chairman Call seconded the motion.

Chairman English called for the vote and it was approved 3-0.

ACTION

Community Development

6. Adopt Resolution 17-14 authorizing the addition of road segments in the Parker Lake area to the County Maintained Road system as described therein.

Ms. Karen Riggs, Highway and Floodplain Director, presented this item using a PowerPoint presentation. Ms. Riggs gave the background and showed a map of the area. She explained that there had been some confusion on which roads in this subdivision should be kept in the County Maintenance system and after some research staff was recommending that the roads shown be added back to the County's Maintenance system as they were still in use and would not greatly impact the highway workplan budget.

Vice-Chairman Call moved to adopt Resolution 17-14 authorizing the addition of road segments in the Parker Lake area to the County Maintained Road system as described therein. Supervisor Judd seconded the motion.

Chairman English called for the vote and it was approved 3-0.

7. Adopt Resolution 17-15 authorizing the abandonment of the Richards Addition subdivision, Docket FPA 17-01 (National Pecan).

Mr. Robert Kirschmann, Planner II, Planning and Zoning Division, presented this item using a PowerPoint presentation. Mr. Kirschmann gave the background and noted that there had not been any concerns about this abandonment.

Supervisor Judd moved to adopt Resolution 17-15 authorizing the abandonment of the Richards Addition subdivision, Docket FPA 17-01 (National Pecan). Vice-Chairman Call seconded the motion.

Chairman English called for the vote and it was approved 3-0.

County Treasurer

8. Approve the recommendation of the County Treasurer for the abatement of property taxes and interest on personal property and the removal of personal property tax liens on Treasurer's Certificate of Clearance No's. 2017-001 through 2017-025 pursuant to A.R.S. 42-19118.

Ms. Cathy Traywick, County Treasurer, presented this item. Ms. Traywick gave the background for the 25 tax bills and said that they had gone through the process and she was recommending that the taxes be abated in order to clear the properties.

Chairman English asked if there was any follow up on these properties that were deemed uninhabitable.

Ms. Traywick said that there was no follow up and the properties were just left to decay.

Chairman English said that she thought the County should follow up.

Vice-Chairman Call moved to approve the recommendation of the County Treasurer for the abatement of property taxes and interest on personal property and the removal of personal property tax liens on Treasurer's Certificate of Clearance No's. 2017-001 through 2017-025 pursuant to A.R.S. 42-19118. Supervisor Judd seconded the motion.

Chairman English called for the vote and it was approved 3-0.
