CALL TO THE PUBLIC

Chairman English opened the call to the public.

No one chose to speak and Chairman English closed the call to the public.

This is the time for the public to comment. Members of the Board may not discuss items that are not specifically identified on the agenda.

PRESENTATION

Presentation by County Attorney's Office on Legal Statistics and Trends for calendar year 2017.

Ms. Orduno presented using a PowerPoint presentation. She gave the background of presenting to the board their statistics and trends annually. She gave a brief overview of all the different types of cases the civil division handles.

Vice-Chairman Call asked Ms. Orduno to separate public records requests by department for future presentations.

Ms. Orduno said she would do so.

The Board thanked Ms. Orduno for the information.

CONSENT

Board of Supervisors

1. Approve the Minutes of the regular meeting of the Board of Supervisors of January 23, 2018.

County Sheriff

2. Approve Agreement #18-LE-11030500-003, between the USDA Forest Service and the Sheriff's Office for a term of January 1, 2018 through December 31, 2018 in the amount of \$10,000 for overtime, employer related expenses and fleet costs for Sheriff's deputies to patrol various recreation areas of the Coronado National Forest.

Court Administration

3. Approve reappointment of Superior Court Judge Pro Tempore, Terry Bannon pursuant to ARS 12-141 and ARS 8-231 and authorize Court Administration to call upon an appropriately appointed Superior Court Judge Pro Tempore from another county in extenuating circumstances pursuant to ARS 12-144 for the period beginning July 1, 2018 to and including June 30, 2019.

4. Approve the appointment of precinct committee member for the Democratic Party upon the recommendation of the Party Chair, Debbie Hickman for Precinct: 30 SV CLOUD - BENJAMIN R. LEVELIUS.

Facilities

5. Approve gas line utility easement for the City of Willcox at the Cochise County Service Center ("CCSC"), 450 S. Haskell Ave, Wilcox, AZ 85643.

Finance

6. Approve demands and budget amendments for operating transfers. Warrants Nos. 23344-23463, 23465-23639, 23641-23813 were issued in the amount of \$1,964,753.69.

Vice-Chairman Call moved to approve items 1-6 on the consent agenda. Supervisor Judd seconded the motion and it carried unanimously.

PUBLIC HEARINGS

Board of Supervisors

7. Approve a Person Transfer/Location Transfer liquor license application for a series #9 (Liquor Store) license submitted by Mr. Suresh Kumar Thathi for Quick Pic Market, located at 62 N. Oak Dr., Benson, AZ 85602.

Ms. Arlethe Rios, Clerk of the Board, presented this item. Ms. Rios said the Sheriff's Office did not have a recommendation and that the Planning and Zoning Department had recommended approval. The Environmental Health Division noted that they would contact the applicant approval. The Environmental Health Division noted that they would contact the applicant regarding any permits needed for the approval of the liquor license; the Treasurer's Office noted that the property taxes are current. The Board staff recommended approval.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Supervisor Judd moved to approve a Person Transfer/Location Transfer liquor license application for a series #9 (Liquor Store) license submitted by Mr. Suresh Kumar Thathi for Quick Pic Market, located at 62 N. Oak Dr., Benson, AZ 85602. Vice-Chairman Call seconded the motion.

Chairman English called for the vote and it was approved 3-0.

ACTION

Board of Supervisors

8. Approve the over-the-counter sale of tax deed properties as set forth in the attached Exhibit A, plus related administrative fees.

Ms. Rios presented this item. She said that there had been two bids received for two parcels for a total sale of \$1,025 (\$875 for the bids and \$150 for the administrative fees). She added that one of the bids was lower than the minimum bid and the bidder had cited noise issues, lack of improvements, current economic trends in the area, and comparable market values for his less than the minimum bid.

Vice-Chairman Call moved to approve the over-the-counter sales of tax deed properties as set forth in the attached Exhibit A, plus related administrative fees. Supervisor Judd seconded the motion.

Chairman English called for the vote and it was approved 3-0.

9. Sitting as the Cochise County Board of Equalization, the Board of Supervisors will uphold or amend the Assessor's decision for the Taxpayer Notice of Claim for parcel numbers 105-16-030 and 208-84-003E.

Mr. Ted Offutt, Chief Appraiser, Assessor's Office, presented this item. Mr. Offut went over the statutes used to value this property and showed pictures of the area.

Chairman English said she would recuse herself because her husband served on SSVEC Board.

Mr. Ron Lee, SSVEC controller, presented his reasons for the appeal and added that the electric lines did have an impact on the value of the property.

Mr. Offutt said that the electric lines on a property did not impact a value and noted that there were many properties in the County that had utility easements with electric lines.

Vice-Chairman Call asked if any other utility companies had taken this position.

Mr. Offutt said that SSVEC was the only company to challenge the valuation set by the Assessor's Office. He added that due to this finding the petitioner wanted to have their property centrally assessed by the Arizona Department of Revenue (ADOR) and not the County Assessor.

Ms. Orduno asked if it was permissible to have ADOR value properties.

Mr. Offutt said that it was permissible, but the petitioner would have to follow ADOR processes to have this happen.

Vice-Chairman Call moved to uphold the Assessor's decision for the Taxpayer Notice of Claim for parcel numbers 105-16-030 and 208-84-003E. Supervisor Judd seconded the motion.

Vice-Chairman Call called for the vote and it was approved 2-0-1 (English recused).

Health & Social Services

10. Approve Intergovernmental Agreement (IGA) #ADHS18-177676 for immunization services between the Arizona Department of Health Services and Cochise Health & Social Services for the period of January 1, 2018 through December 31, 2022 in which funding for the six months from January 1 through June 30, 2018 totals \$75,891, at which point the funding cycle will revert to 12-month periods.

Mr. Ray Falkenberg, Finance Manager, Health & Social Services, presented this item. Mr. Falkenberg gave the background of the program and statistics.

Vice-Chairman Call moved to approve Intergovernmental Agreement (IGA) #ADHS18-177676 for immunization services between the Arizona Department of Health Services and Cochise Health & Social Services for the period of January 1, 2018 through December 31, 2022 in which funding for the six months from January 1 through June 30, 2018 totals \$75,891, at which point the funding cycle will revert to 12-month periods. Supervisor Judd seconded the motion.

Chairman English called for the vote and it was approved 3-0.

County Sheriff

11. Approve a grant from the State of Arizona Border Security Trust Fund in the amount of \$55,633.94 to purchase equipment for border security missions.

Lieutenant Sean Gijanto, Sheriff's Office, presented this item. Lieutenant Gijanto gave the background and noted that the funds would be used to purchase cameras. He added that there was no match required and this would not be used for personnel time.

Vice-Chairman Call asked if there was cost for maintenance and who would monitor data collected by the equipment.

Lieutenant Gijanto said Sheriff's Office staff would monitor the data and maintenance was included in the funding.

Vice-Chairman Call moved to approve a grant from the State of Arizona Border Security Trust Fund in the amount of \$55,633.94 to purchase equipment for border security missions. Supervisor Judd seconded the motion.

Chairman English called for the vote and it was approved 3-0.

12. Approve Agreement with Jake Kartchner and Mike Magoffin for equine service in the amount of \$1,000 each annually for use of their own horses, supplies, and feed associated with this service with automatic annually renewals subject to the termination terms.

Lieutenant Sean Gijanto, Sheriff's Office, presented this item. Lieutenant Gijanto gave the background and stated that this agreement was a renewal and explained how the equine program worked. He said there was only limited liability for veterinary care and no liability for a deceased horse.

Mr. Gilligan stated that there was 100% liability to the County for veterinary services if the horse became injured while on duty.

Ms. Orduno said that if the horse is injured while on duty the County would be fully responsible and noted that she had reached out to the County's insurance pool to ask if additional liability insurance was needed and they said they did not think it was necessary.

Supervisor Judd moved to approve Agreement with Jake Kartchner and Mike Magoffin for equine service in the amount of \$1,000 each annually for use of their own horses, supplies, and feed associated with this service with automatic annually renewals subject to the termination terms. Vice-Chairman Call seconded the motion.

Chairman English called for the vote and it was approved 3-0.

Elections

13. Adopt Resolution 18-01 to approve the Vote Centers for the 2018 Primary and General Elections as listed on the attached Exhibit, and authorize the Elections Director to make substitutions as necessary prior to each election, in the event that a Vote Center replacement needs to be made in accordance with A.R.S. 16-411.

Ms. Lisa Marra, Elections Director, presented this item. Ms. Marra went over the major changes and asked if the Board had any further input for the location of the vote centers.

Supervisor Judd moved to adopt Resolution 18-01 to approve the Vote Centers for the 2018 Primary and General Elections as listed on the attached Exhibit, and authorize the Elections Director to make substitutions as necessary prior to each election, in the event that a Vote Center replacement needs to be made in accordance with A.R.S. 16-411. Vice-Chairman Call seconded the motion.

Chairman English called for the vote and it was approved 3-0.

Housing Authority

14. Approve the Renewal Family Self-Sufficiency Grant FSS17AZ0139-01-00 awarded by the U.S. Department of Housing and Urban Development to the Housing Authority of Cochise County in the amount of \$53,420 for the calendar year 2018.

Ms. Anita Baca, Housing Director, presented this item. Ms. Baca gave the background and highlighted a recent success story with the program. ,

Vice-Chairman Call moved to approve the Renewal Family Self-Sufficiency Grant FSS17AZ0139-01-00 awarded by the U.S. Department of Housing and Urban Development to the Housing Authority of Cochise County in the amount of \$53,420 for the calendar year 2018. Supervisor Judd seconded the motion.

Chairman English called for the vote and it was approved 3-0.
