PRESENTATION

PUBLIC HEARINGS

Board of Supervisors

7. Approve a new liquor license application for a series #13 Farm Winery license submitted by Ms. Carol Park Aden for AZ Backroads Wine LLC, located at the Northeast Corner of Kansas Settlement Road and E. Fawn Ranch Road in Pearce, AZ.

Ms. Arlethe Rios, Clerk of the Board, presented this item. Ms. Rios said the Sheriff's Office did not have a recommendation and that the Development Services Department had recommended approval. The Environmental Health Division noted that they would contact the applicant regarding any permits needed for the approval of the liquor license; the Treasurer's Office noted that the property taxes are current. The Board staff recommended approval.

Chairman Judd opened the public hearing.

County Schools

8. Approve the formation of a technology consortium with other districts in the county administered by Yavapai County who will act as the contractor for E-RATE services.

Ms. Jacqui Clay, County School Superintendent, presented this item. Ms. Clay gave the background of the idea to create a consortium and noted that the cost would be 90% of previous costs through reimbursements from the State for programs to counties who participated. She added that the County Library would also benefit from this consortium and the services it would provide.

Supervisor English moved to approve the formation of a technology consortium with other districts in the county administered by Yavapai County who will act as the contractor for E-RATE services. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

9. Approve an Intergovernmental Agreement (IGA) between the Cochise County Superintendent's Office and the Yavapai County Superintendent's Office where Yavapai County will be the E-RATE consultant effective July 1, 2018 through June 30, 2019.

Ms. Jacqui Clay, County School Superintendent, presented this item. Ms. Clay gave the background and said that Yavapai County would assist Cochise County with this program and it was a decision by several counties that were going to form part of the new consortium.

Supervisor English moved to approve an Intergovernmental Agreement (IGA) between the Cochise County Superintendent's Office and the Yavapai County Superintendent's Office where Yavapai County will be the E-RATE consultant effective July 1, 2018 through June 30, 2019. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

County Treasurer

10. Approve the recommendation of the County Treasurer for the abatement of property taxes and interest on personal property and the removal of personal property tax liens on Treasurer's Certificates of Clearance Nos. 2018-002 to 2018-036.

Ms. Cathy Traywick, County Treasurer, presented this item. Ms. Traywick said that there were 34 items for consideration and thanked the Sheriff's Office for their assistance with this project. She asked that the Board approve her recommendation, which would be a benefit to the community

because it would clean up the tax rolls and possibly bring in additional revenue for the County and the special districts affected.

Supervisor English moved to approve the recommendation of the County Treasurer for the abatement of property taxes and interest on personal property and the removal of personal property tax liens on Treasurer's Certificates of Clearance Nos. 2018-002 to 2018-036. Vice-Chairman Call seconded the motion.
