***CALL TO THE PUBLIC***

Chairman Judd opened the call to the public.

Ms. Karen Lamberton, Sierra Vista Metropolitan Planning Organization (SVMPO) Director, introduced herself in her new role and offered to help each of the Board members regarding any questions on any projects administered by SVMPO.

No one else chose to speak and Chairman Judd closed the call to the public.

Vice-Chairman Call moved to improve items 1-17 on the consent agenda. Supervisor English seconded the motion and it carried unanimously.

### **Board of Supervisors**

18. Approve a new license application for a Class A Bingo license submitted by Ms. Kimmi Lammi, KL Mescal Bar and Grill located at 70 N. Cherokee Trail, Benson, AZ 85602.

Ms. Arlethe Rios, Clerk of the Board, presented this item. Ms. Rios said that all departments had recommended approval of the bingo license and noted that the applicant had paid the processing fee.

Supervisor English moved to approve a new license application for a Class A Bingo license submitted by Ms. Kimmi Lammi, KL Mescal Bar and Grill located at 70 N. Cherokee Trail, Benson, AZ 85602. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

19. Approve a Person Transfer/Location Transfer liquor license application for a series 9 (Liquor Store) license submitted by Mr. Sumit Thathi for Quick Pic Market, located at 62 N. Oak Drive, Benson, AZ 85602.

Ms. Arlethe Rios, Clerk of the Board, presented this item. Ms. Rios said the Sheriff's Office did not have a recommendation and that the Planning and Zoning Department had recommended approval. The Environmental Health Division noted that they would contact the applicant regarding any permits needed for the approval of the liquor license; the Treasurer's Office noted that the property taxes are current. The Board staff recommended

approval.

Chairman Judd opened the public hearing.

No one chose to speak and Chairman Judd closed the public hearing.

Vice-Chairman Call moved to approve a Person Transfer/Location Transfer liquor license application for a series 9 (Liquor Store) license submitted by Mr. Sumit Thathi for Quick Pic Market, located at 62 N. Oak Drive, Benson, AZ 85602. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

20. Approve a series 10 (beer & wine) Acquisition of Control liquor license application submitted by Mr. Sumit Thathi, for Quick Pic Market, located at 62 N. Oak Drive, Benson, AZ 85602.

Ms. Arlethe Rios, Clerk of the Board, presented this item. Ms. Rios said the Sheriff's Office did not have a recommendation and that the Planning and Zoning Department had recommended approval. The Environmental Health Division noted that they would contact the applicant regarding any permits needed for the approval of the liquor license; the Treasurer's Office noted that the property taxes are current. The Board staff recommended approval.

Chairman Judd opened the public hearing.

No one chose to speak and Chairman Judd closed the public hearing.

Supervisor English moved to approve a series 10 (beer & wine) Acquisition of Control liquor license application submitted by Mr. Sumit Thathi, for Quick Pic Market, located at 62 N. Oak Drive, Benson, AZ 85602. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

## **Community Development**

21. Adopt Zoning Ordinance 18-07 approving Docket Z-18-07 Solventix, amending certain zoning district boundaries from R-36 (Residential; one dwelling per 36,000 square feet) to LI (Light Industry), pursuant to the application of Solventix.

Mr. Robert Kirschmann, Planner II, presented this item using a PowerPoint presentation. Mr Kirschmann gave the background:

- The Applicant is requesting rezoning from R-36 (Residential; one dwelling per 36,000 square feet) to LI (Light Industry) on multiple parcels totaling approximately 340 acres south and east of Benson City limits.
- The parcels are located South of East 4th Street and on both sides of Benson Airport Road.
- The east side of Benson Airport Road was the former airport and the West side is currently a farm.

He showed a map of the proposed area, went over the current zoning and the proposed zoning, and noted that the area was developing as planned in the County's comprehensive plan (commercial use). He added that the Planning and Zoning Commission had concerns regarding a berm and staff was recommending a modification to address this concern. He also showed pictures of the location and of the surrounding areas.

He went over factors in favor of approval:

1. Allowing the request would be in keeping with the character of the existing development in the area;
2. The Comprehensive Plan policies prescribe Developing areas to grow towards build-out. This request would infill a large undeveloped area, indicating the direction of future development;
3. The Comprehensive Plan policies prescribe Enterprise areas are to be designated as commercial or industrial. This request would infill a large undeveloped area;
4. Under the University of Arizona Renewable Energy Opportunity Analysis, the Solventix property is identified as suitable for large scale solar facilities.

He went over the factors against:

1. The rezoning may create a land use with more neighborhood impacts than would be permitted under the existing zoning; and;
2. One letter of opposition was received.

He listed the factors to recommend a conditional approval:

1. The Applicant shall provide the County with a signed Acceptance of Conditions and a Waiver of Claims form arising from ARS Section 12-1134 signed by the property owner of the subject property within thirty (30) days of Board of Supervisors approval of the rezoning; and
2. It is the Applicants' responsibility to obtain any additional permits, or meet any additional conditions, that may be applicable to the proposed use pursuant to other federal, state, or local laws or regulations; and
3. The Applicant shall work with right-of-way staff to dedicate additional right to the County; and
4. The Applicant shall maintain the existing berm and vegetation located along the east side of Benson Airport Road.

Modification - The existing vegetation, berm and wash provide adequate screening and no additional solid screening or landscaping would be required.

Chairman Judd opened the public hearing.

No one chose to speak and Chairman Judd closed the public hearing.

Supervisor English stated that this was an appropriate rezoning.

Vice-Chairman Call moved to adopt Zoning Ordinance 18-07 approving Docket Z-18-07 Solventix, amending certain zoning district boundaries from R-36 (Residential; one dwelling per 36,000 square feet) to LI (Light Industry), pursuant to the application of Solventix. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

## ***ACTION***

### **Community Development**

22. Approve a substitution and extension of the Assurance Agreement for Morning Star Airpark with Pioneer Title Agency, Inc as Trustee under Trust No. TR9263 for Morning Star Airpark, LLC as Beneficiary of Trust No. 70200840; Assurance Agreement lapsed April 24, 2017 with a request of extension until April 24, 2025.

Mr. Robert Kirschmann, Planner II, presented this item using a PowerPoint presentation. Mr. Kirschmann gave the background:

- 142 lots on 433.5 acres
- Development in 4 phases
- Zoned RU-4, lots from 1.29 to 1.45 acres
- Conservation Area is 227.7 acres
- The density bonus results in 30 additional lots
- Located on SR 191 and Birch Roadshowed

He showed a map of the location and noted that it was currently used as farmland. He gave additional information:

- Final Plat Approved 2008
- Substitute agreement approved for Mr. Curry in 2012
- Agreement lapsed in April 2017
- Applicant is requesting an extension until April 2025 (8 years including 18 months lapsed)

He noted that the taxes on the property were current, showed the approved plat, and stated that staff recommended approval.

Vice-Chairman Call asked if the applicant had the intention to develop.

Mr. Kirschmann said that the market was not great and noted that this would be the second extension for this applicant.

Mr. Curry, Applicant, said he needed another extension because he believed the economy would head in a positive direction and he hoped this would impact his ability to develop. He added that his development would reduce water usage in the area.

Vice-Chairman Call asked if going from an agriculture classification to a residential classification would increase Mr. Curry's taxes.

Mr. Curry said the taxes would change once the land was developed.

Vice-Chairman Call shared his concerns about extending this more than three years.

Chairman Judd said she did not see an issue on extending this agreement for eight years.

Supervisor English said that this instance was reasonable.

Vice-Chairman Call said he could not support this as there had been no movement on the development and he did not see the economy having an uptick anytime soon.

Supervisor English moved to approve a substitution and extension of the Assurance Agreement for Morning Star Airpark with Pioneer Title Agency, Inc as Trustee under Trust No. TR9263 for Morning Star Airpark, LLC as Beneficiary of Trust No. 70200840; Assurance Agreement lapsed April 24, 2017 with a request of extension until April 24, 2025.

Vice-Chairman seconded the motion.

Chairman Judd called for the vote and it was approved 2-0-1 (Call against).

23. Approve grant agreement GRT-18-0007011-T between the Arizona Department of Transportation Multimodal Planning Division, acting for and on behalf of the State of Arizona, and Cochise County in the amount of \$475,000.

Mr. Martin Haverty, Public Works Director, presented this item. Mr. Haverty said that the grant was from the Arizona Commerce Authority for Economic Strengths and staff would focus improvements on Robbs Road which directly impacts the Viticulture of Cochise County. He mentioned that this project aligned with the Board's strategic plan and noted that Mr. Steve Jones would administer the grant.

Vice-Chairman Call moved to approve grant agreement GRT-18-0007011-T between the Arizona Department of Transportation Multimodal Planning Division, acting for and on behalf of the State of Arizona, and Cochise County in the amount of \$475,000. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

## **Facilities**

24. Approve Fiscal Year 2018-19 Federal Aviation Administration (FAA) Grant offer in the amount of \$55,000 for design only to Replace Runway 17/35 Edge Lighting, Signage, and upgrade Electrical Vault for Bisbee Douglas International Airport, effective September 14, 2018.

Mr. Jay Howe, Facilities Director, presented this item. Mr. Howe said that this was a grant for the second phase of development for the runway and part of the overall plan for the airport development.

Supervisor English moved to approve Fiscal Year 2018-19 Federal Aviation Administration (FAA) Grant offer in the amount of \$55,000 for design only to Replace Runway 17/35 Edge Lighting, Signage, and upgrade Electrical Vault for Bisbee Douglas International Airport, effective September 14, 2018. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

## **Health & Social Services**

25. Approve the Arizona Department of Health Services IGA ADHS17-133164 Amendment #4 for the Emergency Preparedness Program between the Arizona Department of Health Services and Cochise Health & Social Services in the amount of \$237,293, effective July 1, 2018 through June 30, 2019.

Mr. Gregory McQuaide, PHEP Director, presented this item. Mr. McQuaide went over the background of the services provided.

Vice-Chairman Call moved to approve the Arizona Department of Health Services IGA ADHS17-133164 Amendment #4 for the Emergency Preparedness Program between the Arizona Department of Health Services and Cochise Health & Social Services in the amount of \$237,293, effective July 1, 2018 through June 30, 2019. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

26. Approve renewal of Southeastern Arizona Governments Organization (SEAGO)-Area Agency on Aging Grant for Fiscal Year 2018-19, Contract # 107-19 for Case Management between SEAGO and Cochise Health & Social Services in the amount of \$175,000, effective July 1, 2018 through June 30, 2019.

Ms. Bel Elsouhag, Public Fiduciary, presented this item. Ms. Elsouhag gave the background and gave statistics on the services provided. She also explained why this service had been discounted from the County's funding and given to SEAGO.

Supervisor English moved to approve renewal of Southeastern Arizona Governments Organization (SEAGO)-Area Agency on Aging Grant for Fiscal Year 2018-19, Contract # 107-19 for Case Management between SEAGO and Cochise Health & Social Services in the amount of \$175,000, effective July 1, 2018 through June 30, 2019. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.
