

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR MEETING HELD ON
Tuesday, November 27, 2018**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, November 27, 2018 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona.

CALL TO THE PUBLIC

Chairman Judd opened the call to the public.

Ms. Kara Harris, Huachuca City resident, addressed the Board regarding the expansion of Highway 80.

No one else chose to speak and Chairman Judd closed the call to the public.

This is the time for the public to comment. Members of the Board may not discuss items that are not specifically identified on the agenda.

CONSENT

Board of Supervisors

1. Approve the Minutes of the regular meeting of the Board of Supervisors of October 23, 2018.
2. Approve the 2019 Cochise County calendar reflecting the schedule of the Regular Board of Supervisor meetings for the calendar year 2019, the 2019 holidays and pay days, and authorize the Clerk to post the Public Notice of the 2019 meeting schedule.
3. Grant the Cochise County Fair Association permission to apply to host live horse racing in 2019 as required by the Arizona Department of Gaming.

Community Development

4. Adopt Resolution 18-23 to approve participation in the Census 2020 Complete County Committee and encourage every person in Cochise County to be counted.

County Sheriff

5. Approve the renewal of a Memorandum of Agreement (MOA) between Cochise County Sheriff's Office and Fort Huachuca to hold military prisoners in the Cochise County Jail at the current per diem rate of \$318.06 first day and \$61.91 each addition day, effective April 14, 2018 through September 31, 2027.
6. Approve Agreement #18-LE-11030500-003, between the United States Department of Agriculture (USDA) Forest Service and the Sheriff's Office, in the amount of \$10,000 for overtime employer related expenses and fleet costs for Sheriff's deputies to patrol various recreation areas of the Coronado National Forest, effective January 1, 2019 through December 31, 2019.

Court Administration

7. Approve the appointment of retiring Justice of the Peace, Precinct 6, Michael Skiles as Justice of the Peace Pro Tempore countywide for emergency or temporary coverage, pursuant to ARS 22-121 for the period beginning January 2, 2019 through June 30, 2019, with no compensation per agreement with Judge Skiles.

Finance

8. Approve demands and budget amendments for operating transfers, and transfer between funds in attached memo. Warrants Nos. 29576-30125 were issued in the amount of \$2,712,223.46.

Pursuant to A.R.S. §11-217(C), the published minutes shall include all demands and warrants approved by the Board in excess of one thousand dollars except that multiple demands and warrants from a single supplier or individual under one thousand dollars whose cumulative total exceeds one thousand dollars in a single reporting period shall also be published. Issued warrants are listed as an attachment at the end of the minutes.

Vice-Chairman Call moved to approve items 1-8 on the consent agenda. Supervisor English seconded the motion and it carried unanimously.

ACTION

Board of Supervisors

9. Approve the over-the-counter sale of tax deed properties as set forth in the attached Exhibit A, plus related administrative fees.

Ms. Rios presented this item. She said that there had been three bids received for 118 parcels for a total sale of \$11,443 (\$8,493 for the bid and \$2,950 for the administrative fees). She added that one bidder had offered bids below the minimum and cited the parcel location and unavailability of amenities as the reason. Ms. Rios explained that the main goal of these sales were to get parcels back on the tax rolls.

Supervisor English moved to approve the over-the-counter sale of tax deed properties as set forth in the attached Exhibit A, plus related administrative fees. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

10. Approve First Amended Intergovernmental Agreement (IGA) for Animal Shelter Services with Huachuca City.

Chairman Judd allowed a citizen to comment on this item.

Ms. Jere Fredenburgh, Huachuca City Shelter volunteer, addressed the Board regarding her support of this agreement.

Mr. Brandon Morrison, Contracts Administrator, presented this item. Mr. Morrison gave the background and explained the changes.

Mr. Gilligan added that it was a necessary amendment and would be a benefit to the County. He added that staff continued to work on the animal shelter issue on a long term basis, but amending current agreements would benefit the services provided to the citizens.

Vice-Chairman Call moved to approve First Amended Intergovernmental Agreement (IGA) for Animal Shelter Services with Huachuca City. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

County Sheriff

11. Approve the award letter from the Arizona Department of Homeland Security (AZDHS) Grant 2018 in the amount of \$17,000 between (AZDHS) and the Cochise County Sheriff's Office, effective October 1, 2018 through September 30, 2019.

Lieutenant Rich Morales, Sheriff's Office, presented this item. Lt. Morales gave the background and explained that the funding would be used to replace outdated equipment.

Supervisor English moved to approve the award letter from the Arizona Department of Homeland Security (AZDHS) Grant 2018 in the amount of \$17,000 between (AZDHS) and the Cochise County Sheriff's Office, effective October 1, 2018 through September 30, 2019. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

Health & Social Services

12. Approve Amendment #1 to the Arizona Prescription Drug Overdose Prevention Program Contract #ADHS18-180472 between the Arizona Department of Health Services and Cochise Health and Social Services, in the amount of \$125,000, effective September 1, 2018 through August 31, 2019.

Ms. Carrie Langley, Health & Social Services Director, presented this item. Ms. Langley gave the background and explained that the grant would allow the County to establish an opioid fatality review team.

Vice-Chairman Call moved to approve Amendment #1 to the Arizona Prescription Drug

Overdose Prevention Program Contract #ADHS18-180472 between the Arizona Department of Health Services and Cochise Health and Social Services, in the amount of \$125,000, effective September 1, 2018 through August 31, 2019. Supervisor English seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

13. Approve Amendment #5 to the Emergency Preparedness Program Contract #ADHS17-133164 between the Arizona Department of Health Services and Cochise Health and Social Services in the amount of \$180,975, effective September 1, 2018 through August 31, 2019.

Ms. Carrie Langley, Health & Social Services Director, presented this item. She noted that this funding would be focused on substance abuse treatments for inmates.

Supervisor English moved to approve Amendment #5 to the Emergency Preparedness Program Contract #ADHS17-133164 between the Arizona Department of Health Services and Cochise Health and Social Services in the amount of \$180,975, effective September 1, 2018 through August 31, 2019. Vice-Chairman Call seconded the motion.

Chairman Judd called for the vote and it was approved 3-0.

REPORT BY EDWARD T. GILLIGAN COUNTY ADMINISTRATOR -- RECENT AND PENDING COUNTY MATTERS

Mr. Gilligan said that the new payroll system would go live on December 16, 2018 and that process was ongoing with several departments participating in the pilot. He also commented on the amendment to the Southeastern Arizona Communications (SEACOM) Center agreement.
