2. Approve the Library Services and Technology Act (LSTA) grant from the Arizona State Library, Archives & Public Records, in the amount of \$4,000 for large print books for homebound readers for Cochise County, effective May 8, 2020 through August 6, 2021.

4. Approve the Coronavirus Aid, Relief, and Economic Security (CARES) Act Expanded grant from the Arizona State Library, Archives & Public Records, in the amount of \$4,000, for mobile printing service, for Cochise County branch libraries, effective June 15, 2020 through August 6, 2021.

Ms. Amadee Ricketts, Library Director, presented this item. She said mobile printing will make it possible for people using branch libraries to print from their phones, tablets, and mobile devices, without getting on public computers, providing more access and less physical contact. This will allow two branch libraries to be equipped for a year.

Chairman Borer asked if we had received any public comment on this item. Ms. Tucker stated there was none.

Supervisor Judd moved to approve the Coronavirus Aid, Relief, and Economic Security (CARES) Act Expanded grant from the Arizona State Library, Archives & Public Records, in the amount of \$4,000, for mobile printing service for Cochise County branch libraries, effective June 15, 2020 through August 6, 2021. Vice-Chairman seconded the motion.

Chairman Borer called for the vote and it was approved 3-0.
