SHERIFF & COUNTY EXECUTIVE

WHEREAS, are requirement of the HALT Act, the Sheriff’s Office needs to provide out-of-cell trauma-informed therapeutic programming to promote personal development and address the underlying causes of problematic behavior among incarcerated populations, and

WHEREAS, Peaceprints of Western New York (PPWNY) has created the Hustle 2.0 curriculum which is a 348-page, softcover Hustle Guide with 12 evidence-based courses each packed with self-assessments, journal exercises, case studies, testimonials, and success stories; and

WHEREAS, PPWNY will employ and assign a qualified programming coordinator to work at both facilities; and

WHEREAS, the Sheriff's Office will fund year one of the program with Telephone Revenue Funds; and

WHEREAS, the cost of the program coordinator is \$39,000.00; and

WHEREAS, the Sheriff's Office and PPWNY will enter into an agreement which will end December 31, 2023, and will not exceed \$39,000.00 for a program coordinator, and

WHEREAS, the Sheriff and the County Executive agree the aforementioned position and agreement are necessary for the operation of the Erie County Holding Center and the Erie County Correctional Facility; and

WHEREAS, the expenditure for a HALT Act program coordinator complies with COMM. 6E-24, 2013, which states that Telephone Revenue "shall be dedicated to the general operation of the Holding Center and Correctional Facility"; and

WHEREAS, as of February 6, 2023, the Telephone Revenue account has a balance of \$509,635.00; and

WHEREAS, this resolution transfers \$39,000.00 from the Telephone Revenue account, and this resolution will not impact the 2023 County Budget.

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Legislature authorizes the County Executive and the Erie County Sheriff's Office to enter into an agreement with Peaceprints of Western New York, 660 Smith St, Buffalo, NY 14210 that will not exceed \$39,000.00 and will expire December 31, 2023; and be it further

RESOLVED, that the Erie County Legislature authorizes the Erie County Sheriff's Office and the Division of Budget and Management to transfer \$39,000.00 in available Telephone Revenue funds to the appropriate Erie County Sheriff's Office accounts:

Section 4-B. Cents per gallon rate of sales and compensating use taxes on motor fuel and diesel motor fuel.

to two dollars per gallon of either such fuel. Provided that, if the average price of such fuels changes as described in such subdivision (m) of section 1111 of the Tax Law, the Commissioner of Taxation and Finance shall adjust the cents per gallon tax rate on such fuels in the manner prescribed in such subdivision (m) of section 1111 of the Tax Law.

WHEREAS, Erie County experienced an unprecedented Blizzard in which a State of Emergency was declared from December 23, 2022 to January 22, 2023; and

WHEREAS, in an effort to alleviate this backlog, the Department of Social Services assisted families that lost loved ones during the State of Emergency who could show financial hardship but otherwise would not have qualified for Burial Assistance under the current program.

WHEREAS, eFMAP is used to help control property taxes; and

WHEREAS, this budgetary tactic would cost New York City \$345,000,000 and the counties outside of New York City \$280,000,000; and

WHEREAS, according to a New York Association of Counties report, the impact on Erie County would be annual loss of revenue of \$26,639,482; and

WHEREAS, based on Erie County's current property tax levy, which increased 2.7% for this year, a further increase of 8.17% to next year's property tax levy would be required to make up for this shortfall alone; and

WHEREAS, based on comments made by the New York Senate delegation of the United States State, it is clear that these funds were intended to pass-thru to the counties, and not just be spent by the states; and

WHEREAS, given the 2% property tax cap that exists for counties across New York State, such a move will result in significantly decreased services without any accompanying savings for Erie County taxpayers.
