SUMMARY

ECDOH is seeking authorization to accept a grant from The National Association of County and City Health Officials (NACCHO) for \$10,000 to assist with costs for training, clothing, supplies, and other miscellaneous items for Erie County Medical Reserve Corps. ECMRC provides support to all of Erie County and its municipalities during public health emergencies and disasters. Trainings are encouraged by New York State for local MRCs to gain the knowledge of developing their own policies and properly prepare, deploy, demobilize, and recover for planned and unplanned operations that involve volunteers of the MRC. This award will specifically help with training MRC volunteers into Tier Level 3 status, allowing them to be deployed to emergencies, and provide the deployment bags filled with first aid kits and other supplies.

FISCAL IMPLICATIONS

Positive.

REASONS FOR RECOMMENDATION

This award is to ensure that Public Health Preparedness staff and MRC volunteers have the necessary skills and knowledge to assist during public health and emergency operations.

CONSEQUENCES OF NEGATIVE ACTION

Erie County's MRC will not have the necessary knowledge and skills to carry out the policies of the MRC as encouraged by New York State.

STEPS FOLLOWING APPROVAL

ECDOH will work with Budget and Management to add the award to their operating budget.

WHEREAS, the Erie County Department of Health's Public Health Preparedness division works directly with the Medical Reserve Corps, a volunteer organization that assists in public health and emergency operations; and

WHEREAS, The National Association of County and City Health Officials (NACCHO) has awarded \$10,000 for trainings and supplies for the Erie County Medical Reserve Corps; and

WHEREAS, this award will be used to train MRC volunteers into Level 3 Tier so they may be deployed to emergencies outside local jurisdictions, and provide the necessary deployment bags and supplies; and

WHEREAS, the funds will provide the necessary training for the skills and knowledge for MRC volunteers as well as supplies and clothing to participate in other community events and trainings throughout Erie County and its 44 municipalities.
