Re: 2025 Mortgage Expenses

Dear Clerk Kearns:

At the Erie County Legislature committee meeting on May 29th 2025, concerning mortgage tax, your office stated that you had neither submitted nor sought any deduction of Clerk expenses for mortgage tax collection from the New York State Department of Taxation and Finance for 2025, despite the Legislature authorizing you to do so.

Pursuant to New York State law, a County Clerk, Registrar or County Treasurer may submit the MT-3 Mortgage Expense Request to the New York State Department of Taxation and Finance. After that hearing and in consultation with the New York State Department of Taxation and Finance, my office submitted an MT-3 request, along with County Legislature resolution Intro. 5-8 certifying the 2025 expense number.

The New York State Department of Taxation and Finance accepted the County's request on June 6th (see attached). Accordingly, you are authorized by the State to deduct \$112,050.33 every month (for a total of \$672,302 for 2025) for the final six months of 2025.
