SUMMARY

Erie County Department of Mental Health has received additional funds from NYS Office of Mental Health (OMH) for mental health providers and agencies for mid-year adjustments and one-off expenses related to services, treatments, programs, and capital expenses. Additional funds include:

\$200,000 for Living Opportunities of DePaul

FISCAL IMPLICATIONS

None. These funds are awarded by New York State and distributed through Erie County.

REASONS FOR RECOMMENDATION

These additional awards, designated and funded by OMH, are to help providers with various expenses for their operations or capital expenses related to expanding services.

CONSEQUENCES OF NEGATIVE ACTION

Erie County's providers would not receive the full funding they are awarded by OMH and could negatively impact their services, treatments, programs, and capital expenses.

STEPS FOLLOWING APPROVAL
