SUMMARY

A project to design the rehabilitation of the Marshfield Road (CR 500) Bridge over North Branch Clear Creek, BIN 3328610, in the Town of North Collins, was authorized by your honorable body via Communication 3E-6 (2024). To advance the construction of this locally administered Federal Aid project, benefiting from both Federal and State Funding, the County will, at 100%, undertake the Right of Way acquisition. The purpose of this resolution is to allocate funding and authorize the County of Erie to acquire the necessary Right-of-Way for rehabilitation of the bridge. The right-of-way required is comprised of a total of five takings, within three different properties. Three (3) fee takings are needed, and two (2) Temporary Easements are needed.

FISCAL IMPLICATIONS

Funds for these ROW acquisitions are available SAP B.25051, 2025 Capital Right-of-Way, Fund 420, BA 123.

REASONS FOR RECOMMENDATION

Allow the County to acquire necessary Right-of-Way for the rehabilitation of the subject bridge.

BACKGROUND INFORMATION

This Project has funding in SAP account B.25051, Capital Right-of-Way. Acquisition of the Rightof-Way is necessary prior to the construction phase of the project.

CONSEQUENCES OF NEGATIVE ACTION

If Right-of-Way is not acquired, the project cannot be constructed, and the bridge will continue to deteriorate and hinder travel for the general public.

STEPS FOLLOWING APPROVAL

The Right-of-Way necessary to construct the project will be acquired.

WHEREAS, a design project for rehabilitation of the Marshfield Road (CR 500) Bridge over North Branch Clear Creek, BIN 3328610, in the Town of North Collins, (the "Project") was authorized by your honorable body via Communication 3E-6 (2024); and

WHEREAS, to facilitate the rehabilitation of this bridge, it is necessary for the County to acquire by fee and/or easement portions of real property in the vicinity of the bridge;

WHEREAS, such properties to be acquired by the County are herein referred to as the "Subject Properties"; and

WHEREAS, to acquire the easement parcels for the Project, it is necessary for the County to establish an amount which it believes to represent just compensation for the real property interest to be acquired and to thereafter make a written offer to purchase the real property interest for the respective just compensation amount; and

WHEREAS, the acquisition of the portions of the Subject Properties is de minimis in nature so that the public interest will not be prejudiced by the construction of the new bridges; and

WHEREAS, should one or more owners of the Subject Properties refuse to convey such portions of their real property to the County for an amount not exceeding fair market value, it will be necessary for the County to acquire the Subject Properties by commencing eminent domain proceedings.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby authorizes the acquisition of the necessary Right-of-Way (ROW) required for Marshfield Road (CR 500) Bridge project over North Branch Clear Creek, BIN 3328610, in the Town of North Collins; and be it further

RESOLVED, that sufficient funding is available for the acquisitions is available from Fund 420, Fund Center 123, project B.25051, 2025 Capital Right of Way in a sum not to exceed \$20,000; and be it further

RESOLVED, that authorization is hereby given for the County Executive to enter into all necessary contracts and agreements for the acquisition of the required ROW to construct the Project; and be it further

RESOLVED, that authorization is hereby given to the Commissioner of Public Works, or his authorized representatives, including Colliers Engineering & Design, Architecture, Landscape Architecture, Survey, CT P.C., to establish the amounts representing just compensation for the real property to be acquired; and be it further

RESOLVED, that authorization is hereby given to the Commissioner of Public Works, or his authorized representatives, including Colliers Engineering & Design, Architecture, Landscape Architecture, Survey, CT P.C., to negotiate and offer just compensation amounts to the owners of the Subject Properties for the purpose of acquiring interests in portions of their respective parcels of real property by fee and/or easement, which acquisitions are necessary for the Project; and be it further

RESOLVED, that authorization is hereby given for the Commissioner of Public Works, or his authorized representatives, including Colliers Engineering & Design, Architecture, Landscape Architecture, Survey, CT P.C., to act on behalf of the County of Erie in connection with the acquisition of the required ROW from the owners of the Subject Property; and be it further

RESOLVED, that the County Attorney shall prepare, and the County Executive shall execute all appropriate documents relating to acquiring fee and/or easement interests in the Subject Properties; and be it further

RESOLVED, should one or more owners of the Subject Properties refuse to convey such portions of their real property to the County for an amount not to exceed the just compensation determined by the Commissioner of Public Works, or his authorized representatives, the County is authorized to commence eminent domain procedures; and be it further

RESOLVED, that the Clerk of the Legislature forward three (3) certified copies of this resolution to the Department of Public Works, Office of the Commissioner, and one copy each to the Office of the County Executive, the Division of Budget and Management, and the Office of the Comptroller.
