SUMMARY

This resolution is seeking authorization for the County Executive to enter into contracts with the lowest responsible bidders for work associated with Erie County Youth Detention – Interior and Exterior Security Improvements project. This project involves addressing interior and exterior security elements at the County Youth Detention Facility located at 810 East Ferry Street, Buffalo, NY 14211. General, Mechanical, Electrical, and Plumbing construction bids were received by the Department of Public Works on July 18, 2025 and a copy of the bid tabulations are attached for your reference.

FISCAL IMPLICATIONS

REASON FOR RECOMMENDATION

This project is recommended to address observations and concerns from a security inspection by the Erie County Sherriff's Office and to support the ongoing needs of the facility, including continued physical improvements to accommodate older individuals as a result of the Raise the Age law.

BACKGROUND INFORMATION

The Youth Detention Facility was designed and built to encourage a culture of learning and rehabilitation. Efforts were made to use commercial grade building materials, as opposed to creating an institutional environment. Unfortunately, years of high use with a population that has a tendency to be aggressive has resulted in damage to the facility which creates health and safety concerns. Physical improvements to the interior and exterior of the building will be made to satisfy the safety and security concerns of housing older youth as a result of NYS Raise the Age Law. The recommended improvements derive from an Erie County Sheriff's Office Security Inspection report.

CONSEQUENCES OF NEGATIVE ACTION

If the interior and exterior security improvements are not completed, safety and security concerns will remain which pose a risk to occupants and staff.

STEPS FOLLOWING APPROVAL

Upon Legislative approval, the County Executive will enter into contracts with the lowest responsible bidders so work can proceed.

COMPTROLLER'S OFFICE REVIEW

The proposed legislation has been reviewed by the Comptroller's Office and is related to an authorized capital project for which there are sufficient appropriations for the action proposed.
