SUMMARY

The Department of Public Works (DPW) is requesting authorization for the County Executive to enter into a contract with the lowest responsible bidders for the SUNY Erie Community College (ECC) North Campus Dry Memorial Library Exterior Rehab project, located at 6205 Main Street, Williamsville, New York 14221. Bids were received by the department on October 28, 2025. A copy of the bid tabulations is attached for your reference.

This project involves building-wide exterior masonry reconstruction, repointing, and cleaning, replacement of all exterior window and storefront systems, reconstruction of the main entrance grand stairs, replacement of all hallway, corridor and entryway heating system and original exhaust systems, lobby lighting and ceiling replacement, and other miscellaneous work.

FISCAL IMPLICATIONS

Funds for the project are currently available from the approved, as adopted Erie County Capital Budget, Fund 480, Funds Center 122 as follows:

The County will receive 50% reimbursement from New York State for this project.

REASONS FOR RECOMMENDATION

The existing window and storefront systems at the Dry Memorial Library have far exceeded their useful life. In order to reduce maintenance costs associated with temporary "stop-gap" measures to keep the building weathertight, a full replacement is warranted. Significant energy savings will be achieved utilizing energy efficient commercial low-emissivity insulated window and storefront replacement systems, and new perimeter, entrance, and hallway heating systems.

BACKGROUND INFORMATION

The Dry Memorial Library was constructed in 1959 and was part of a campus-wide renovations and expansion in 1967.

The existing window and storefront systems are the original 60-year-old non-thermally broken, energy inefficient aluminum storm window system with single pane glazing added to the interior of the existing original storefront, which eliminated the opportunity to open the original

windows. JMZ Architect's Building Condition Assessment has evaluated that the majority of the existing exterior window system for the building is in fair or poor condition, defined as conditions at a minimally and below minimally acceptable level. Previous exterior glazed masonry repair work by the College at outside corners of the main entrance is not uniform and in poor condition. Concrete stairs located at east and west entrance are cracked and deteriorating and in need of repair. Steel railings are rusting at their base and were previously painted as part of deferred maintenance.

The building entry and hallway heating is achieved with convector units which are original to the 1958/1967 building and are near the end of their reliable service life, and in fair condition. The lobby lighting and ceilings are original to the building.

CONSEQUENCES OF NEGATIVE ACTION

If this project is not completed, the existing exterior windows, storefront, and curtain wall systems will continue to deteriorate, and ultimately, closure of the facility because it will become unsafe to occupy.

STEPS FOLLOWING APPROVAL

Upon Legislative approval, the County Executive will enter into a contract with the lowest responsible bidders.

WHEREAS, the existing window and storefront systems at the Dry Memorial Library are the original 60-year-old non-thermally broken aluminum storm window system with single pane glazing added to the interior of the existing original storefront and in poor condition; perimeter fin-tube, entrance, and hallway heating systems are original to the building; and

WHEREAS, replacing the existing single paned window and storefront, system, perimeter fin-tube, entrance, and hallway heating systems will increase energy efficiency within the building; and

WHEREAS, the County has obtained approval form the State Historic Preservation Office (SHPO) to proceed with the construction project as designed since the ECC North Campus is listed on the State Registry of Historic Places; and

WHEREAS, the County of Erie received bids for the SUNY Erie Community College North Campus Dry Memorial Library Exterior Rehab project on Tuesday, October 28, 2025 in accordance with General Municipal Law; and

WHEREAS, the lowest responsible bidder for the General Construction Work is Resetarits Construction Corporation, for the Mechanical/Plumbing Construction Work is John W. Danforth Company; and for the Electrical Construction Work is Ferguson Electric Inc.; and

WHEREAS, the County will receive 50% reimbursement from New York State for this project; and

WHEREAS, the Department of Public Works and Watts Architecture and Engineering are recommending award of the contract to the lowest responsible bidders.

NOW, THEREFORE, BE IT

RESOLVED, that the County Legislature hereby authorizes the County Executive or Deputy County Executive to enter into a contract with the lowest responsible bidders for the SUNY Erie Community College North Campus Dry Memorial Library Exterior Rehab project for an amount not to exceed as follows:
