### **SUMMARY**

Acceptance and approval of Contract No. 68 in the final contract amount of \$1,063,925.18 together with Change Order No. 1 (final), a decrease of \$161,636.69 as well as authorization to issue final payment to the contractor, Visone Construction, Inc. is requested.

### **FISCAL IMPLICATIONS**

There will be no impact on the County's General Fund. The funds for this contract were allocated from Capital Account No. C.21150 (American Rescue Plan funds) and Erie County Sewer District No. 6 Capital Reserve Account No. C.00006. No additional funding is requested.

### **REASONS FOR RECOMMENDATION**

All scheduled improvements required by the contract documents have been completed. As a result, it is the Department's recommendation to finalize this contract.

### **BACKGROUND INFORMATION**

Contract No. 68 was bid on October 1, 2024 and awarded by the Erie County Legislature on October 24, 2024 pursuant to Legislative Comm. 15E-4 (2024). All funding was reviewed by the Erie County Comptroller's Office prior to various actions by the Erie County Legislature. This contract constructed the Lackawanna Open Cut Excavation Sanitary Sewer Replacements in Erie County Sewer District No. 6. Change Order No. 1 (Final) is an adjustment of final quantities resulting in a decrease of \$161,636.69 to the total contract value.

### **CONSEQUENCES OF NEGATIVE ACTION**

Contract default on the part of the County of Erie could be claimed by the Contactor.

### **STEPS FOLLOWING APPROVAL**

The County of Erie will execute the final change order and make a final payment to Visone Construction, Inc.
