1. Roll Call and Declaration of Quorum

- The Art in Public Places Committee was called to order by Chairperson Wajed at 12:20 PM. Roll call was taken by Ms. Balisteri, and a quorum was declared present.

2. Approval of Draft Minutes

- Upon motion by Mr. Wajed and seconded by Chairperson Wajed, the draft February 11, 2026 meeting minutes were unanimously approved. Ms. Radle abstained having been absent from the February 11, 2026 meeting.

3. Selection Committee Report by Chair

- Chairperson Wajed provided an overview of the 2026 Major Works Selection Committee meetings held on April 27th and May 4th.

- The Selection Committee is recommending “Isle View: Submission 4” be chosen for the Isle View Project location and the 2026 Call for Artists for the Buffalo and Erie County Botanical Gardens project location be reopened.

- Upon motion by Ms. Radle and seconded by Mr. Wajed, the Arts in Public Places Committee unanimously approved the selection of Isle View: Submission #4 as the awardee of the 2026 Call for Artists for the Isle View Park project.
