## MEMORANDUM

**REF** Series 7 Liquor License Application Person Transfer for Grand Canyon Spirits

---

On January 17<sup>th</sup>, 2018, I initiated an investigation into an application for a Location Transfer on a series 7 liquor license for Grand Canyon Spirits. Grand Canyon Spirits is currently located 982 N Fort Valley Road and operating with a Series 9 license that was issued in 2017. Cecily Clift-Maniaci (Agent and Controlling Person) is the current owner of the location and is looking to stack this Series 7 license at this location with her existing Series 9 so alcohol can be consumed on-site. The Series 7 license was purchased from Michael Funk. The license number is 07033001.

I spoke with Cecily who will be running the day to day operations, and she said she is the sole owner of the business. Cecily said the store will be a full liquor store on one side with a combination of liquor, beer and wine, and an area to consume alcohol on site. She said there will also be a convenience section of the store as well. Cecily stated there will be some sort of barrier between the non-alcoholic side and the alcohol side. Cecily provided proof she has completed the mandatory liquor law training course. Cecily said the business hours would be from 7:00 a.m. to 9:00 pm daily.

During the 2017 Series 9 investigation, measurements were taken to verify the proposed license location is outside 300 feet from any school or church. Due to the close proximity of Flagstaff High School, a Pro Laser III Infrared Lidar System was used to measure from the southwest corner of the building to the northeast corner of the fence to Flagstaff High School Football Field. This measurement came out to be 311.6 feet. The location is also outside 300 feet from any church.

I conducted a query through our local systems and public access on Cecily and found no derogatory criminal records. Cecily also is the agent on five other liquor licenses in Flagstaff. She possesses two series 9 licenses at the current location at 982 N Fort Valley Road (#09030048 and #09S030001672, a tasting license). She also possesses two series 12 licenses (#12033414 and #12033384) and a series 10 license (#10033220) in Flagstaff. I did not locate any violations against these five licenses being operated in Flagstaff. Cecily had a previous violation for delinquent taxes in March of 2014 with Grand Canyon Spirits located at Building 469 Route 64, Grand Canyon, but she now longer possesses this license at this location. This administrative violation was paid.

Cecily advised she would be able to attend the February 5<sup>th</sup> council date.
