instruct its attorneys regarding the public body's position regarding contracts that are the subject of negotiations, in pending or contemplated litigation or in settlement discussions conducted in order to avoid or resolve litigation., pursuant to A.R.S. Section 38-431.03(A)(1) and (4), respectively.
