Use and Ownership Restrictions as described in that certain document titled **Declarartion of Ownership, Use & Occupancy Restrictions Pine Canyon Golf Club - Club Cabins Unit 1** recorded in the Coconino County Records Office, Instrument 3864317.

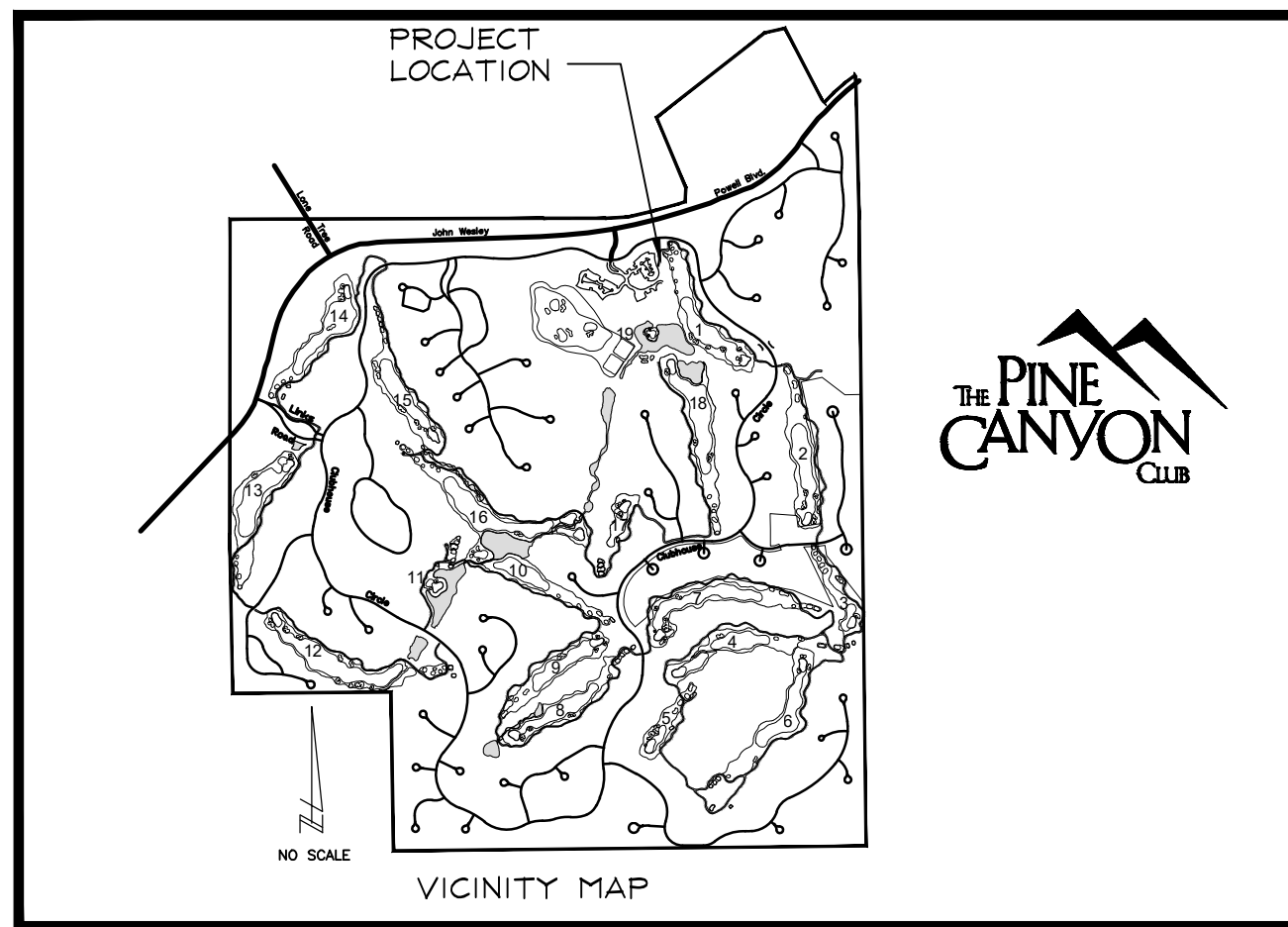
(a) **Use Restrictions.** Units may only be used or occupied by: (i) Pine Canyon Owners and Pine Canyon Club Members, and their families and invited guests; and (ii) invite only "Discovery Visits" for prospective Club Members and members of the public with a demonstrated interest in purchasing a Lot within the Pine Canyon Community. No single stay may exceed 28 contiguous days.

(b) **Ownership Restrictions.** Units may only be owned by: (i) the Pine Canyon Club; or (ii) Pine Canyon Club Members. Units may be: (i) transferred between Pine Canyon Club Members; or (ii) if a Unit owner dies or surrenders the underlying Club Membership for any reason, the Unit may be transferred or willed to a Club Member (collectively, "Permitted Transfers").

(c) **Maintenance and Repair.** The Pine Canyon Club shall be responsible for overseeing the operation, maintenance and repair of each Unit.

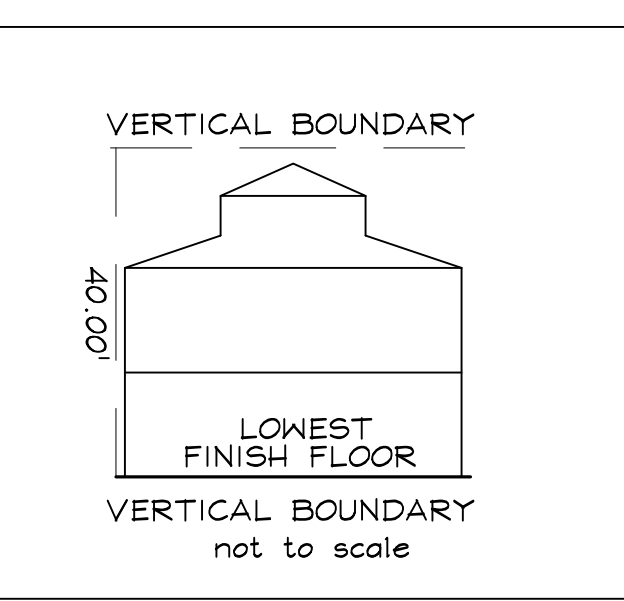
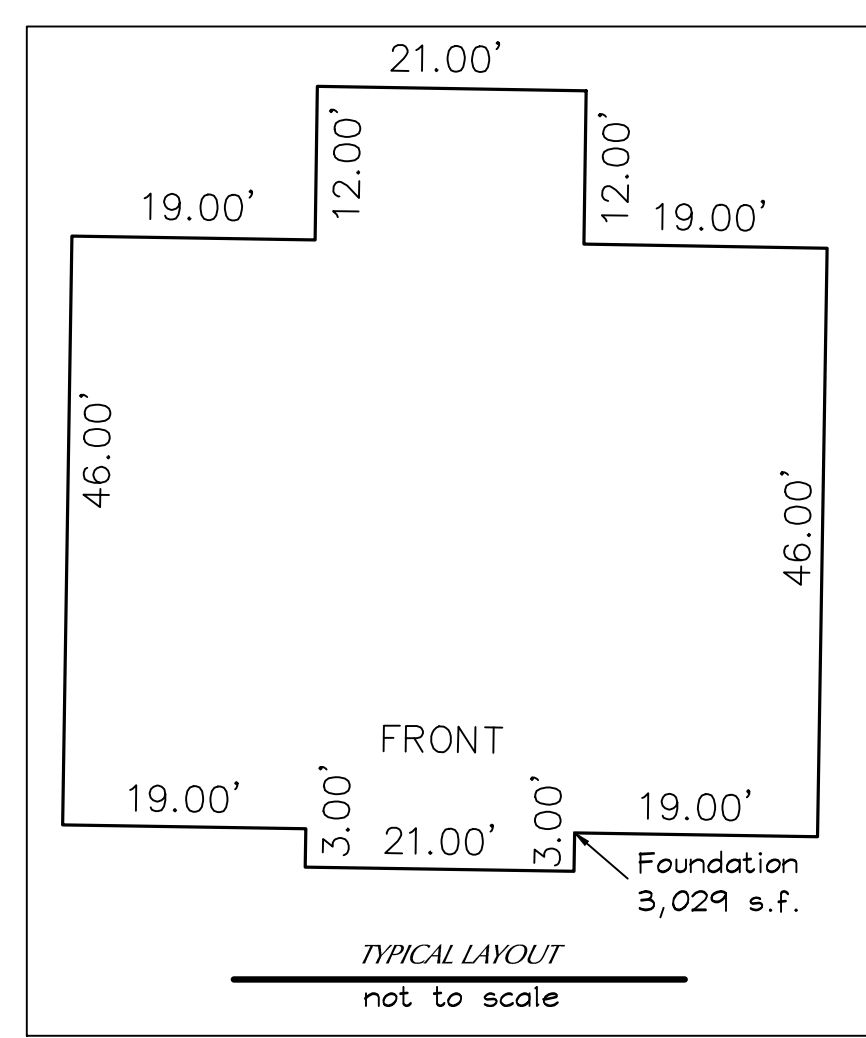
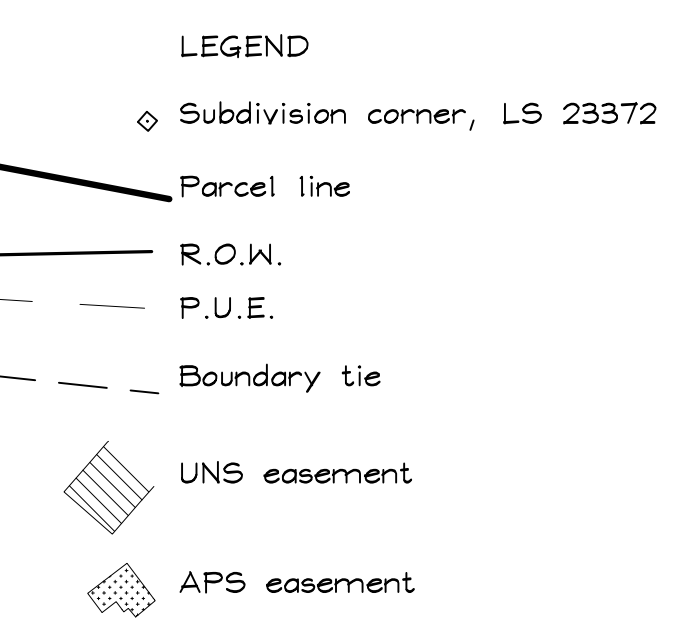
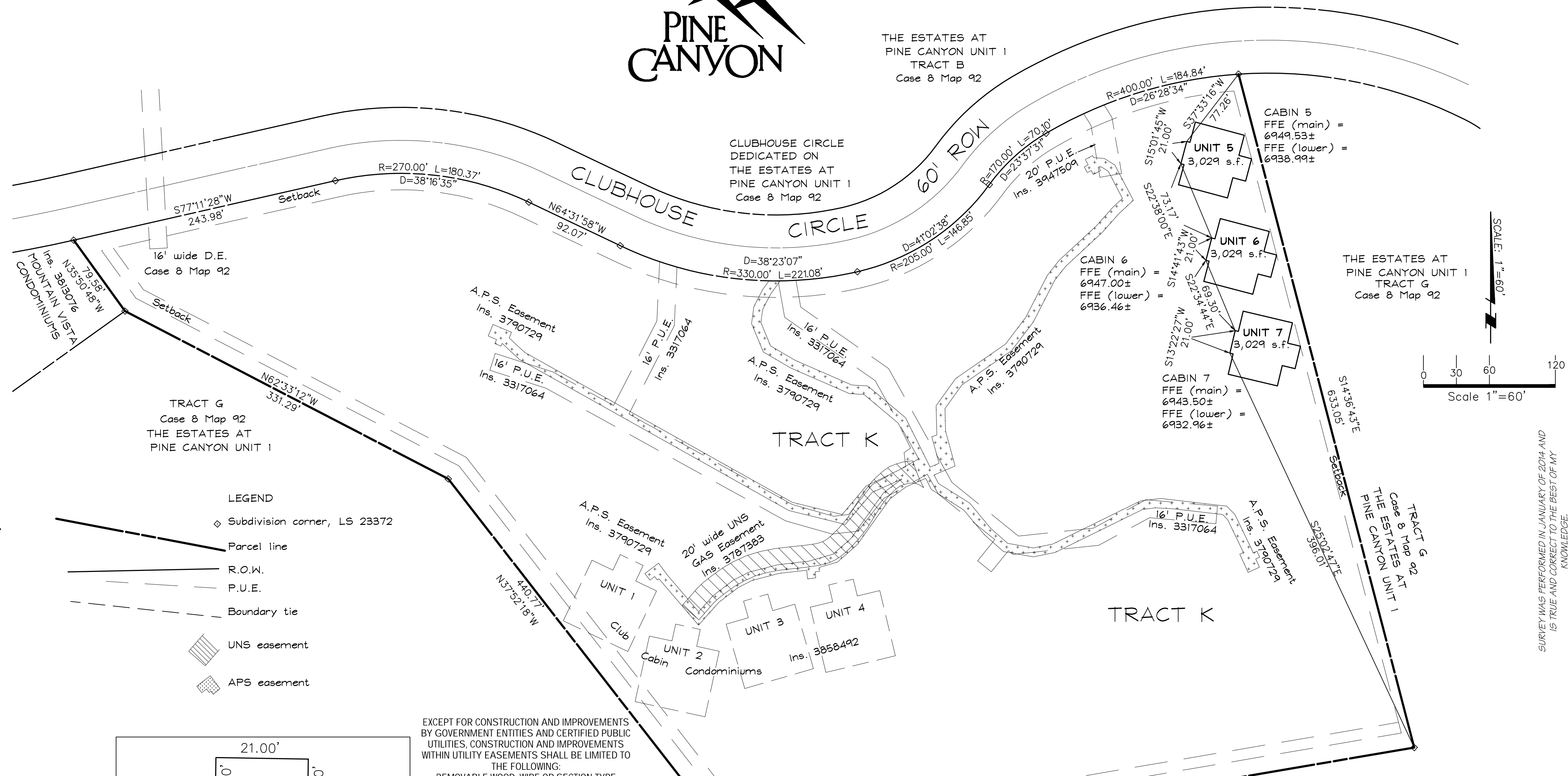
(d) **Insurance.** The Pine Canyon Club shall be responsible for coordinating casualty and general liability insurance with respect to each Unit.

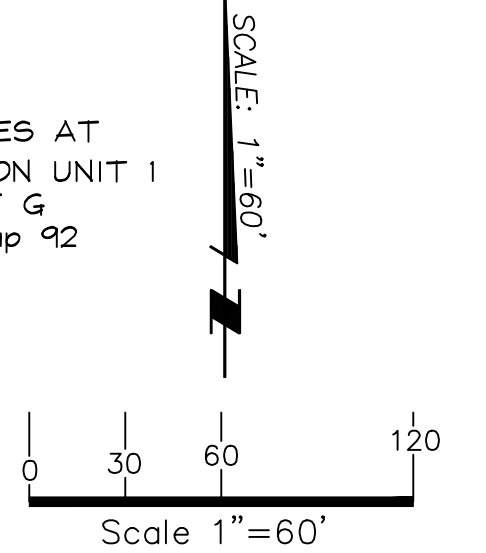
